#### Term of Office:

The Chairman, Vice-Chairman and Members of the Sub-Divisional OBC Development Board shall hold their position in the board at the pleasure of the State Govt. The State Govt. may at any time change the Chairman/Vice-Chairman/Member of the Development Board or may dissolve the Development Board or may reconstitute the Development Board.

The Development Board shall stand dissolved on completion of three years from the date of notification, unless dissolved earlier.

#### Functions of the Board:

- 1. To select and approve list of schemes / beneficiaries under various developmental programmes funded by the Government.
- 2. To oversee implementation of development schemes executed by various Sectoral Departments of the State Government for the benefit of the community concerned.
- 3. To ensure progress of implementation of schemes and proper utilization of grants sanctioned under Department of Social Justice & Empowerment.
- 4. To review the OBC schemes and offer suggestions on proper implementation of the same to the State Government.
- 5. The Board shall sit at least 3 (three) times in a financial year.
- 6. The Board shall monitor the implementation of schemes and report to the Government through SDWO.

The Constitution, Conduct of Business, Functions etc. of the Sub-Divisional OBC Development Board shall be carried on as per Govt. Notification No. TAD/BC/440/2013/63, Dated 6th September, 2021.

#### The 27th March, 2024

**No. HMA-19015/9/2019-Political(A)/Pt-1/93.-** Whereas, the Government of Assam in exercise of powers conferred under Section 3 of the Armed Forces (Special Powers) Act, 1958 (Act 28 of 1958) had declared the areas covering 4 (Four) districts viz. (1) Tinsukia; (2) Dibrugarh; (3) Charaideo; and (4) Sivasagar of the State of Assam as "Disturbed Area" vide notification No. HMA-19015/9/2019-Political(A) /74 dated 27th September, 2023 with effect from 1st October, 2023 for a period of 6 (six) months;

Whereas, Assam Police Headquarters have submitted a report showing the improvement of Law and Order situation in the state of Assam barring one militant organization being active in 4 districts of Assam viz. Tinsukia, Dibrugarh, Sivasagar and Charaideo and offered views that the imposition of "Disturbed Area" under Armed Forces (Special Powers) Act, 1958 may be continued in the above mentioned districts of Assam beyond 31st March, 2024.

And whereas, Govt. of Assam in Home & Political Department submitted a proposal to this effect to Govt. of India, Ministry of Home Affairs vide this Department's letter No. ECF- 200043/91 dated 14th March, 2024.

And whereas, Ministry of Home Affairs, Govt. of India, after due consideration of the proposal informed the Govt. of Assam vide letter No. 11011/51/2015-NE.V dated 27th March, 2024 to maintain "status-quo" regarding "Disturbed Areas" in State of Assam for a further period of six months w.e.f. 1st April,

2024.

Now, therefore, in exercise of the powers conferred under Section 3 of the Armed Forces (Special Powers) Act, 1958 and in supersession of earlier Notification vide No. HMA- 19015/9/2019-Political(A)174 dated 27th September, 2023, the Governor of Assam is pleased to declare the areas covering 4 (Four) districts viz. (1) Tinsukia; (2) Dibrugarh; (3) Charaideo; and (4) Sivasagar of the State of Assam as "Disturbed Area" for a further period of 6 (six) months w.e.f. 1st April, 2024, unless withdrawn earlier.

# The 1st April, 2024

**No. HMA. 214/2022/116.-** Whereas, a Departmental proceeding was drawn up against Shri Raj Mohan Ray, APS (U/S), the then Superintendent of Police, Darrang vide this Department's letter No.HMA.214/2022/35 dated 6th December, 2022 on charges of gross negligence and dereliction of duty, serious lapses in supervision of a serious case of alleged rape and murder of a minor girl and misconduct; and,

Whereas, Shri Raj Mohan Ray, APS (U/S), submitted his written statement in defence dated 19th January, 2023 to this Department, wherein he denied the charges framed against him; and;

Whereas, having not been satisfied with the written statement in defence submitted by Shri Raj Mohan Ray, APS (U/S) and after careful consideration of all aspects, the Government decided to inquire into the allegations and therefore appointed Shri Akhilcsh Kr. Singh, IPS, the then Inspector General of Police (STF), Assam as Inquiry Officer to inquire into the charges framed against Shri Raj Mohan Ray, APS (U/S) vide order No. HMA.214/2022/55 dated 9th March, 2023, and;

Whereas, the Inquiry Officer after causing an inquiry into the charges submitted his report to the Disciplinary Authority vide letter No.TAP/C/60/RMR/2023/192 dated 26th September, 2023 wherein the Inquiry Officer concluded that out of the three allegations, one is proved whereas the other two are partially proved, and;

Whereas, a copy of the inquiry report dated 26th September, 2023 was shared with Shri Raj Mohan Ray, APS (U/S) for submitting his written representation, if so desired, vide letter No.HMA.214/2022/105 dated 13th October, 2023, and;

Whereas, Shri Raj Mohan Ray, APS (U/S) submitted his written representation dated 6th November, 2023 which was placed before the disciplinary authority for consideration.

Now, therefore, after careful examination of the report of the Inquiry Officer and materials on record, in consideration of the facts and circumstances of the case as well as the written representation dated 6th November, 2023 and after due consultation with the Assam Public Service Commission, the Governor of Assam is pleased to order the penalty of "dismissal from service, which shall ordinarily be disqualification for future employment" as per provision of Rule 7 (vii) of the Assam Service (Discipline & Appeal) Rules, 1964.

The Governor of Assam is therefore pleased to dismiss Shri Raj Mohan Ray, APS (U/S), the then Superintendent of Police, Darrang from service with immediate effect and the Departmental Proceedings drawn up against him arc thus finally disposed of.

#### **ORDER**

The 21st March, 2024

**No. HLA. 78176/629.-** Whereas, Shri Jugal Baruah, Ex Inspector of Drugs, Dhemaji was put under suspension w.e.f. 13th July, 2018;

Whereas Shri Jugal Baruah, Ex Inspector of Drugs, Dhemaji has filed an appeal petition dated 15th September, 2023 before the Chief Secretary, Assam against this Department's order No.HLA.78176/432 dated 12th September, 2023, whereby a major penalty of Compulsory Retirement was imposed upon him, on grounds of getting arrested red handed while accepting illegal remuneration by officials of Vigilance & Anti-Corruption;

Whereas Shri Jugal Baruah preferred an appeal petition dated 15th September, 2023 against the penalty order which was then forwarded by the Chief Secretary, Assam to this Department for taking necessary action.

Whereas the same petition dated 15th September, 2023 was filed by Shri Jugal Baruah before the Hon'ble Governor of Assam.

Whereas Shri Jugal Baruah also approached the Hon'ble High Court by filing Writ Petition WP(C) 7334/2023 praying for quashing the Department's order dated 12th September, 2023, and the same being disposed by providing that the statutory appeal preferred by the petitioner which be heard and disposed by a reasoned order.

Whereas upon such appeal being made by Shri Jugal Baruah and having perused all relevant documents and evidence thereof in connection with suspension of Shri Jugal Bauah w.e.f. 13th July, 2018 on ground of being arrested by officers of Directorate of Vigilance and Anti Corruption, it has been evident -

- 1. That the standard proof required in a departmental inquiry differs materially from the standard proof required in a criminal trial and that the material is not sufficient for proof in a criminal trial can be held sufficient in a departmental proceeding, the latter is that of preponderance of probability and not proof beyond doubt which is the proof required in a criminal trial, requiring a high level of satisfaction based on materials and facts in all elements of offence.
- 2. That in case of Smti. Jahnabi Kalita who was serving in the capacity of Inspector of Drugs in Jorhat was arrested by the Officials of Directorate of Vigilance and Anti Corruption on 17th September, 2022 while accepting gratification of Rs. 20,000/-, the amount being recovered from the drawer of the office chamber and that on the other hand Shri Jugal Baruah, while functioning as Inspector of Drugs, Jorhat was caught red handed while accepting gratification of Rs.20,000/-, having handed over an envelope to the Complainant, indicating bribe money should be put in the envelope upon which the complainant put the money in the envelope and Shri Jugal Baruah touched the currency while pushing money into envelope and so Shri Jugal Baruah has apparently not only committed the offence of accepting money for settling certain irregularities but also acted in a pre-planned way; so, the circumstances leading to arrest and being taken to custody for demanding gratification in case of Shri Jugal Baruah and Smti. Jahnabi Kalita are different.
- 3. That Shri Birinchi Karjee while serving as Designated Food Officer, Nagaon while accepting bribe of Rs. 10,000/-, the amount being less than that the amount of bribe for which Jugal Baruah was arrested and so cannot be considered to be deserving of same penalty.

Shri Jugal Baruah was offered an opportunity of hearing on 5th March 2024 wherein he has furnished a written submission. Shri Baruah has submitted that he is not guilty and mentioned about procedural aspects of the case.

Whereas, on grounds so stated above, the Department sees no ground of quashing the major penalty of compulsory retirement on grounds of arrest while accepting illegal gratification by officials of vigilance and Anti Corruption and rather feels it is justified to stick to such original decision, the same being decided out consequent to findings of Inquiry Report so furnished by the Officer appointed for the purpose of inquiring into facts of acceptance of bribe.

Hence, the penalty of Compulsory Retirement imposed upon Shri Jugal Baruah vide this Department's order No. HLA. 78176/432 dated 12th September, 2023 is upheld and hence, the appeal petition disposed of.
