EXECUTIVE ORDER

The 25th February, 2022

No. HLA.669/2007/Pt/530.- Pending finalization of the Assam Dental Health Service Rules, 2022, the Governor of Assam is pleased to make the following orders for promotion and recruitment in the cadres of Dental Surgeon and Senior Dental Surgeon, under the Health & Family Welfare (A) Department, Assam.

1. Short title and Commencement;-

- (i) This order may be called the Assam Dental Health Service (Direct Recruitment and Promotion of Dental Surgeon) Order, 2022.
- (ii) It shall come into force on the date of publication in the Official Gazette.
- 2. Definition:- In this order , unless the context otherwise requires:
 - a. "Appointing Authority" means the Governor of Assam.
 - b. "Committee" means Selection Committee constituted under Clause 5(iii).
 - c. "Board" means Medical & Health Recruitment Board.
 - d. "Government" means the Government of Assam.
- Class and the Post:- The service shall consist of the posts and cadres as mentioned in Schedule – I
- 4. Procedure for Direct recruitment:-

(i) Direct recruitment to the post of Dental Surgeon shall be made by the Governor on the basis of recommendation made by the Board in accordance with the procedure hereinafter provided:

- a) Before the end of the each year the Appointing Authority shall make an assessment regarding the likely number of vacancies to be filled up by direct recruitment during the next year and shall intimate the same to the Board together with the details about reservations of candidates belonging to Scheduled Castes, Scheduled Tribes (Hills), Schedule Tribes (Plans) and any other category as laid down by Government from time to time.
- b) The Appointing Authority shall simultaneously request the Board to recommend a list of candidates for direct recruitment in order of preference equal to the number of actual vacancies.
- c) The Board shall make the selection of candidates in accordance with the scheme of selection prescribed by the Government in consultation with the Board. The Board may hold such test or interview and undertake scrutiny of certificates and any other document as may be considered necessary.
- d) The Board shall furnish government with a list of candidates recommended by it in order of preference, found suitable for direct recruitment. The number of candidates in such list may be equal to actual number of vacancies notified as per 'AFRBM Act, 2005'.
- e) The Board shall simultaneously publish the list in Assam Gazette or such other places as the board may considered proper.
- f) The select list mentioned in the Clause (d) of the rule shall remain valid for twelve calendar months from the date of recommendation.

(ii) In the event of the Board being unable to recommend sufficient number of candidates to fill the vacancies in a year, it shall, in consultation with the appointing authority, repeat the procedure as mentioned herein before under sub-rule (1) of this Rule, for recommending a subsequent list in a year, provided that the Appointing Authority shall not make appointment of any candidate from the subsequent list until all the candidates of the earlier list of the same year, eligible for appointment, have been offered the appointment.

- 5. Procedure for Promotion:- (i) Subject to possessing such qualification and experience as prescribed hereinafter, a member shall be eligible for promotion against vacancies in the corresponding higher post in the manner hereinafter provided:
 - (a) A Dental Surgeon shall be eligible for holding the post of Senior Dental Surgeon, if he/she has completed 10 (ten) years of continuous service in the post on the first day of January of the year in which the selection is made and the Governor is satisfied about his/her ability, integrity and character.

(ii) All promotions are subject to availability of existing and resultant vacancies against each cadre or as provided in ACPS vide notification No. FPC/109/2010/42 dated 25/05/2011.

(iii) Selection Committee:- The Selection for promotion will be made by a Selection Committee constituted with the following namely:-

Senior-most Secretary, Health & FW Department	:	Chairperson.
Director of Health Services, Assam	:	Member.
Representative of Personnel Department		
(Not below the rank of Deputy Secretary)	:	Member.
Representative of WPTBC Department		
(Not below the rank of Deputy Secretary)	:	Member
Joint/ Deputy Secretary, Health & FW Department	:	Member Secretary.

- (iv) The Selection Committee after perusal of the ACRs & APRs (minimum 3 years) and other relevant service records shall recommend the officer, if found suitable, for promotion to the post of Senior Dental Surgeon, Chief Dental Surgeon and Joint Director of Dental Services.
- 6. Relaxation: Where the Government is satisfied that the operation any of these orders causes undue hardship in any particular case, it may dispense with or relax the requirement these provisions to such extent and subject to such conditions as it consider necessary for dealing with the case in a just and equal manner. Provided that the case of any person shall not be dealt with any manner less favourable to him that provided in this order.
- 7. Reservation: In all cases of promotion to the service, there shall be reservation in favour of candidate belonging to Scheduled Caste, Scheduled Tribes as per the provision of the Assam Scheduled Cast and Scheduled Tribes (Reservation of vacancies in service and post) Act, 1978 and Rules framed there under.
- 8. Interpretation: If any question arises as to the interpretation of this order, the decision of the Govt. shall be final.
