No. E-341687/613.- In supersession of all earlier Notifications issued in this regard, the Governor of Assam is pleased to notify the following guidelines for selection of candidates for appointment to the posts of Supervisors against 25% reserved quota from amongst the in-service Anganwadi Workers in General Area districts:

A. ELIGIBILITY CRITERIA:

1. The candidate must be serving as an Anganwadi Worker engaged with due approval of the Director, Women & Child Development, Assam, and must have completed 10 years of continuous service as an Anganwadi Worker as on the 1st January of the year in which advertisement is issued.
2. Serving Anganwadi Workers of General Areas districts only shall be eligible to apply.
3. The candidate must possess educational qualification as required for direct recruitment to the post of Supervisor, /i.e. Graduate in Arts/ Science/ Commerce/ Allied disciplines from a university recognized by the Government of Assam.
4. The candidate must be eligible in all respects to hold the post of Supervisor.
5. Only those candidates who, on the date of their proposed appointment as Supervisor, have not attained the age of 60 years shall be considered for appointment.

B. SELECTION PROCESS:

1. The selection process shall be conducted at the State level by the Director, Women and Child Development, Assam, hereinafter referred to as the Director.
2. The total posts of Supervisors and posts available against 25% reserved quota shall be considered by taking into account the regular posts in General Area districts only.
3. Extant reservation orders as applicable for direct recruitment shall be duly followed.
4. The Director shall take necessary steps to issue advertisement and collect Application Forms from intending eligible Anganwadi Workers. The advertisement will indicate, inter alia, number of vacancies proposed to be filled up, the eligibility criteria, number of posts to be reserved for candidates from various categories, manner in which Application Forms are to be submitted

- and the last date for submission of Application Forms. The Director shall take necessary steps for collection and scrutiny of such Application Forms to finalize the list of candidates eligible to participate in selection process.
5. A State Level Written Test (MCQ) of total 80 marks consisting of questions on Nutrition, ECCE, General Awareness and General English will be conducted by the Director from amongst the eligible candidates for short listing of candidates based on merit with due consideration to vacancy under each category.
 6. A computer proficiency test for 20 marks will be conducted by the Director from amongst the above-mentioned shortlisted candidates for preparing the select list equal to the number of vacancies to be filled up under each category.
 7. If deemed necessary, the Director may entrust any or all of the processes of collection of application forms, conduct of State Level Written Test (MCQ) and the computer proficiency test to one or more external Government agencies. Admit Cards/Call letters etc., if issued by the agency, will be issued with the approval and on behalf of the Director.
 8. The Director shall publish the select list of candidates and take steps for appointment following due process. No candidate in the select list shall be appointed who, at a later stage, is found to be ineligible to hold the post of Supervisor.
 9. Verification of documents will be done for the selected candidates before their appointment. In case of failure to submit satisfactory documents in support of eligibility criteria, the candidature of such candidate shall be rejected.
 10. All rules and procedure of the State/Central Government that conform to the present requirements but not incorporated herein above shall also be followed accordingly.
 11. The Director or the Government agencies involved may take steps as deemed necessary for carrying out the selection process subject to extant Government rules and procedure.
 12. The Director and, as the case may be, the Government agency involved shall keep all records in safe custody.
 13. Anyone aggrieved with provisions contained in this Notification relating to criteria/conditions etc. may approach this office for any modification/alteration etc.

This comes into force with immediate effect.

No. 474188/1.- In exercising provision of Rule 47 (l) Assam Treasury Rules 2017 and in order to enhance efficiency in monthly accounts rendering, the digital submission of treasury accounts to the Office or the Accountant General (A&E), Assam was introduced in a phased manner in the financial year 2023-24. Provision of digital signature for authenticating salary bills was introduced in the month of September 2023 and this enabled online submission of corresponding vouchers. Subsequently, submission of works and forest vouchers was made online from December 2023 as per the Assam Treasury (amendment) Rules, 2023. Now, to ensure 100% online submission of accounts, the following procedure is laid out:

1. All Administrative Approvals and financial sanctions must be issued online in IFMIS. Further, Drawing & Disbursing Officers (DDOs) shall prepare and submit all types of bills electronically through IFMIS with digital signature.
2. However, the bills which are not digitized for cash drawal in bank for secret service, PLA cheques etc. shall be submitted manually until further notification.
3. For all such contingency, works, forests bills etc., where sub-vouchers are applicable, DDOs shall upload such vouchers with digital signature. Every sub-voucher shall bear a pay order signed and initialed by the responsible disbursing officer, specifying the amounts payable both in words and figures in ink.
4. DDOs shall upload scanned pdf of the counter signed bills as attachment in case of TA bills and any other bills wherever countersignature or competent authority is necessary as per provision of executive orders /specific rules etc. All paid vouchers and sub-vouchers must be stamped "paid" and "cancelled" by DDOs in such a manner that it cannot be subsequently used for fraudulent claims. DDOs shall make necessary certificate of stock entry on the body of the sub voucher wherever necessary.
5. After submission of the claims for payment by DDOs in Fin Assam (FMIS), the hard copy of the paid vouchers and sub vouchers shall be preserved till meeting up of audit observation pertaining to the particular financial year. After that, the vouchers shall be disposed of as per order of competent authority and as per Assam Public Records Rules, 2019 and such other relevant rules/notifications issued from time to time.
6. Cash Challans shall be minimized to the extent possible by leveraging e-GRAS.
7. The complete reports of treasury accounts and returns as prescribed in Assam Treasury Rules, 2017 and the Accounting Rules for Treasuries, 1992 along with digital vouchers shall be rendered to the Office or the Accountant General (A&E), Assam, electronically within 10th of the succeeding month. The paid hard copy of the PLA cheques, cash challans, paid cash drawal vouchers etc. shall be submitted to the Office of the Accountant General (A&E), Assam for custody along with the digital vouchers.

This notification shall amend all those provisions of the Assam Treasury Rules, 2017 in contravention with the present system of digital submission of bills /vouchers and Treasury accounts. The above procedure for rendering monthly accounts online for all treasuries shall be effective from 1st April, 2024.
