The Chairman, Vice-Chairman and Members of PIC of the ITDP shall hold their position in the board at the pleasure of the State Govt. The State Govt. may change the Chairman/Vice-chairman/Member of the board at any time. Moreover, the term of office of the board shall not exceed 3 years.

**Function of the PICs:**

- 1) To select and approve list of schemes/beneficiaries under various developmental programmes funded by the Government.
- 2) To oversee implementation of development schemes executed by various Sectoral Departments of the State Government for the benefit of relevant community.
- 3) To ensure progress of implementation of schemes and proper utilization of grants sanctioned under WPT & BC Department.
- 4) To review the ITDP schemes and offer suggestions on proper implementation of the same to the State Government.
- 5) The PIC shall sit atleast 3(three) times in a financial year.
- 6) The Board shall monitor the implementation of schemes and report to the Government through PD, ITDP.

The Governor of Assam is also pleased to nominate PCCF (Biodiversity) to act as the Secretary to the Assam Biodiversity Board.

**Term of Office :**

The Term of office of the Chairperson and members (other than ex-officio members) shall be 3 (three) years.

**Power, function and responsibilities :**

Without prejudice to the provision of the Biological diversity Act, 2002 (Act 18 of 2003) the Assam Biodiversity Board shall exercise powers, perform function and discharge responsibilities as laid down and mandated under the " Assam Biodiversity Rules, 2010".

**Powers and responsibilities of the Chairperson :**

The Chairperson shall exercise such powers and discharge such responsibilities as laid down and mandatory under section-15 of the "Assam Biodiversity Rules, 2010" .

**Function of the Secretary :**

The Secretary of the Assam Biodiversity Board shall perform such function as laid down and mandatory under section-11 of the "Assam Biodiversity Rules, 2010".

**Terms of Reference of the Assam Bio-diversity Board :**

1. The Activities of the Assam Biodiversity Board shall be essential and strictly governed by the provisions of the Assam Biodiversity Rules, 2010.
2. The Assam Biodiversity Board shall consult the National Bio-diversity Authority (NBA) and the Biodiversity Management Committees , as and when required, while taking decision relating to use of biological resources of the state and traditional knowledge associated with such resources.



3. The Assam Biodiversity Board shall, in the discharge of its functions and responsibilities under the Assam Bio-diversity Rules, 2010 be bound by such direction on question of policy as the state Government may give of it writing from time to time under sub-sections (1) of section -49 of the Biological Diversity Act, 2010. Provided that the Assam Biodiversity shall as far as practicable be given an opportunity to express its views before any direction is given under the said provision.
4. The Principal Chief Conservator of Forests (Biodiversity) will function as the Secretary of the Assam Biodiversity Board.
5. The Assam Biodiversity Board would from time to time as required.
6. TA/DA of non-official members would be born out of funds provided by the State Government for the purpose/State Biodiversity Fund. TA/DA of officials members would be borne by their respective parent Departments.
