**Sub : Fixation of maximum rates of hiring charges of vehicles for General Election, 2019.**

In supersession of all earlier Notification regarding fixation of rates of hiring and in pursuance of section 4 of the Assam Requisition and Control of Vehicle Act, 1968 (Assam Act, V of 1969), the maximum rates of hiring of the different categories of vehicles per diem and the daily allowances of driver, conductor and handyman may be fixed as given below with immediate effect for General Elections, 2019 only.

The taxes as applicable shall be extra.

**Daily Allowance :** The daily allowance for driver of the vehicles will be Rs.350.00 (Rupees three hundred fifty) only and that of conductor / handyman will be Rs. 280.00 (Rupees two hundred eighty ) only.

Further, the provision of bus conductor for election purpose is not admissible. Additional charges beyond 300 km will also not be admissible after this instant revision of rates of vehicles.

**The following terms and condition shall apply in hiring of vehicles for the public purposes mentioned above.**

1. Under no circumstances a vehicle shall be hired an-route while the passengers are on board.
2. While hiring of vehicles, as far as practicable, vehicles from other States should not be hired. If however, such vehicles are hired they shall be entitled for payment as per hiring rates applicable in their States.
3. When a vehicle is hired repairing charge is to be borne by the owner. Therefore, while hiring a vehicle, the hiring authority should ensure that the vehicle is properly insured, so that the owner can claim damages from Insurance Companies in case of accident etc.
