NOTIFICATION

The 24th April, 2019

No.ACL/43/2004/4372-440.- In pursuance of Notification No. ACL/43/2004/8240-306, dtd. 30th May, 2017, the rate of VDA to be paid to workman employed by and through contractors as mentioned below in respect of cases which are not covered under Minimum Wages Act, 1948 and where the workmen employed by the contractors do not perform the same or similar nature of work as done by workers, directly employed by the Principal Employers of the establishment. The following rates are fixed on the 100% rise on average all India Consumer Price Index (base 2001=100) from the period July, 2016 (CPI Points 280) to December, 2016 (CPI Points 275).

Now it is hereby, notified that, following VDA shall be payable to the following categories in the table calculated below w.e.f. 01/01/2017.
