Government have decided, therefore, to introduce the following system with immediate effect, which must be strictly adhered to in sending notice to the Assam Government Press for publication in the official Gazette.

1. In the first instance, it has to be noted that the printing of the weekly Gazette must be completed by the end of every Tuesday so that it may be duly published on every Wednesday.

- 2. Every notification and every other matter which is required to be printed and published in a particular issue of the Official Gazette must, therefore, reach the Deputy Director, Assam Government Press on the Monday of the week preceding the week in which it is required to be published.
