ORDER

AGA.217/2019/302. Read the order passed by Hon'ble Gauhati High Court, in case No: WP (C) No: 1748/2021 (Smti Geetanjali Kalita & 3 Ors-vs-State of Assam) dated 17-03-2021 pertaining to the matter of age relaxation of candidates viz Smti Geetanjali Kalita, Shri Kuntal Kalita, Shri Haramohan Das and Shri Kamaleswar Bhattacharjee who had already applied for the post of Village Level Extension Worker (VLEW) pursuant to earlier advertisements dated 24-12-2013 and 13-09-2014 issued by Agriculture Department for condoning the upper age limit and to allow them to participate in the selection process for the post of Agriculture Extension Assistant (AEA earlier known as VLEW) pursuant to advertisement dated 26-02-2021 issued by agriculture department.

-AND-

Whereas, a total of 2,16,996 nos. of application were received in response to the advertisement published on 24/12/2013 & 13/09/2014 for 858 nos. VLEW (now AEA) post. Out of these, a good numbers of applicant including the petitioners had applied for condonation of upper age limit for applying for the advertised VLEW posts and accordingly, condonation was done by the Directorate of Agriculture, Assam as per rule i.e based on the Govt. OM No. ABP.73/89/17, dated 04/01/1992.

-AND-

Whereas, in accordance with the Govt. O.M. No. ABP.73/89/17, dated 04/01/1992 upper age limit may be granted up to the age of 45 years and therefore, the candidates who had availed relaxation of upper age limit during 2013 & 2014 cannot be considered for further relaxation during 2020-21 since their age has already crossed well over 45 years.

-AND-

Whereas, in compliance of the Hon'ble Guwahati High Court's common judgment dated 03/03/2016 passed in WP(C).No. 6187/2015 and WP(C).No. 6205/2015 a fresh advertisement has already been issued & published on 26/02/2021 for the post of AEA (then VLEW) along with other posts and in doing so earlier advertisements dated 24/12/2013 & 13/09/2014 had to be cancelled and it has been mentioned in the fresh advertisement published on 26/02/2021. Therefore, admit cards issued pertaining to earlier advertisements seem to have no effect towards age relaxation of over aged candidates with reference to fresh advertisement.

-AND-

Whereas, pertaining to the earlier advertisement admit cards were generated by the Assam Agricultural University, Jorhat and the database related to this is not available with this Directorate in order to authenticate the admit cards submitted by the petitioners.

-AND-

Whereas, however, last date of online submission of application for the posts has already been extended to 5th April, 2021.

After perusal and consideration of all above facts, this department is of view that in the greater interest of public, the age relaxation in respect of the petitioners is not feasible as per Govt. Rules. Also this may invite further complicacies in the recruitment process which is of utmost importance for the Agriculture Department. Hence, the prayer petition of the petitioners cannot be considered.
