No. RLA.231/2018/51.- It is hereby notified that in pursuance of S.6 (1) of the Assam Land (Requisition and Acquisition) Act,1964 (Assam Act XV of 1964), the Collector, Kamrup is pleased to decide the acquisition with effect from the date of publication of this notice of the land requisitioned under S.3 (1) of the said Act as per schedule below, measuring as area of 3(three) Bighas 0 (Zero) Katha- 0 (Zero) Lecha in village-Pacharia, Mouza- Pub-Bongsor in the District of Kamrup for the purpose of *Construction of double land road from Amingaon-Hajo-Nalbari road (at Singimari) to NH-31 (Chowkigate) via Pacharia and Bangalgarh by strengthening and widening of existing single lane road*".
