Now therefore, the Governor of Assam is pleased to order that the Commissioner, Lower Assam Division shall be the Designated Authority to determine the territorial limits of the 26 (twenty six) constituencies for the General Council of the Kamatapur Autonomous Council in accordance with the provisions of the Act;

And the Governor of Assam is further pleased to order that the Designated Authority shall publish draft Delimitation Order, invite claims, comments, views and objections from , political parties, groups and individuals, carry out necessary hearings and take other necessary actions as may be required for the purpose and complete the whole exercise within a period of 4 (four) months from the date of issue of this notification.

Dated 28th July, 2022 in violation of the laid down Standard Operating Procedure regarding seizure of arecanut/betelnut foreign origin and norms for providing technical advice in such matters and the charges were framed with gross negligence of duties, defrauding/ cheating, dereliction of duty, lack of administration and doubtful integrity which is unbecoming of a Govt. servant under the provision of Rule-3 of the Assam Civil Service (Conduct) Rules, 1965.

# -AND-

Whereas Shri Longjam Iboyaima Sinha, DAO, Cachar, Silchar had submitted his written statement vide his letter dated 24th August, 2022, wherein he categorically denied the charges framed against him.

# -AND-

Whereas, not being satisfied with the written reply submitted by the Delinquent Officer, the disciplinary authority further decided to place it to the State Enquiry Officer and all relevant documents have been forwarded vide Government Notification No. E-207259, dated 1st November, 2022 with a request to submit an Enquiry report thereof.

# -AND-

Whereas, as per the findings of State Enquiry Officer the charges framed against Shri Longjam Iboyaima Sinha, DAO, Cachar, Silchar as not physically verifying/ analysing the Indian Areca Nut sample from the seized stock, not complying with the SOP issued by the Govt., for not providing detailed reasons for identification of the Betel Nut sample as of Indian origin by the expert committee, have not been sustained.

Whereas, after careful examination of the enquiry report and on the basis of all the other relevant supportive documents and having regard to evidences and circumstances appearing in the case, the Governor of Assam is pleased to accept the findings of the Enquiry Officer, Assam and is of the opinion that the Departmental Proceeding drawn up against the Delinquent Official is to be dropped.

Accordingly, the Governor of Assam is pleased to conclude the departmental proceeding drawn up against Shri Longjam Iboyaima Sinha, DAO, Cachar, Silchar (Now Retired) vide No. AGA.258/ 2022/9.
