NOTIFICATION

No.PDA.244/2016/145.- In exercise of the powers conferred by sub-section (1) of section 141 of the Assam Panchayat Act, 1994 (Assam Act No. XVIII of 1994), the Governor of Assam is hereby pleased to make the following rules further to amend the Assam Panchayat (Administrative) Rules,2002, hereinafter referred to as the principal Rules, namely:-

Short title, and
commencement

- (1) These rules may be called the Assam Panchayat (Administrative) (Amendment) Rules, 2020.
- (2) They shall come into force on the date of their publication in the Official Gazette.

Amendment of rule 13

- In the principal Rules, in rule 13, in sub-rule (iii), in 2nd line, after the words "monthly remuneration", for the words, figures, brackets and punctuation marks, "Rs. 3,500/- (Rupees three thousand and five hundred) out of the devolution of fund to the Zilla Parishad and Zilla Parishad's own resources", the following shall be substituted, namely :-

" Rs. 4,000/- (Rupees four thousand) out of the devolution of fund to the Zilla Parishad and Zilla Parishad's own resources."

Amendment of rule 14

- In the principal Rules, in rule 14, in sub-rule (iii), in 2nd line, after the words "monthly remuneration", for the

words, figures, brackets and punctuation marks, “Rs. 2,500/- (Rupees two thousand and five hundred) out of the devolution of fund to the Anchalik Panchayat and Anchalik Panchayat’s own resources”, the following shall be substituted, namely :-

“Rs. 3,000/- (Rupees three thousand) out of the devolution of fund to the Anchalik Panchayat and Anchalik Panchayat’s own resources”.

Amendment of rule 15

4. In the principal Rules, in rule 15, in sub-rule (iii), in 2nd line, after the words “monthly remuneration”, for the words, figures, brackets and punctuation marks, “Rs. 1,500/- (Rupees one thousand and five hundred) out of the devolution of fund to the Gaon Panchayat and Gaon Panchayat’s own resources”, the following shall be substituted, namely :-
- “Rs. 2,000/- (Rupees two thousand) out of the devolution of fund to the Gaon Panchayat and Gaon Panchayat’s own resources”.
