#### **ORDER**

## The 29th April, 2023

**No. FRE.82/2020/595.-** Whereas, a departmental proceeding was drawn up against Sri Prafulla Chandra Lahkar, AFS, the then Forest Ranger, Lekhapani Range, under Digboi Division, Digboi and a show cause notice was issued vide Letter No. FRE.82/2020/42, dated l0th September, 2020 along with Statement of Allegation of charges, List of Exhibits, to Shri P.C. Lahkar in respect of the following charges:

- 1. Charge No.1: Failure to prevent gross violation of the Forest (Conservation) Act, 1980.
- 2. Charge No.2: Failure to discharge statutory duty of preventing commission of forest offence prescribed under section 61 of the Assam Forest Regulation, 1891.
- 3. Serious dereliction of Government duty resulting in massive illegal coal mining in forest area.

The defence statement submitted by the delinquent officer has been received in the Department on 18th January, 2021.

Whereas, on being not satisfied with the defence statement submitted by the Delinquent Officer, the Environment & Forests Department instituted a Departmental enquiry by appointment of a Presenting officer vide Letter No. FRE.82/2020/267-A, dated 26th February, 2021 and Inquiry Officers vide Letter No. FRE.82/2020/267, dated 26th February, 2021.

Whereas, the enquiry officer, Shri Suvashish Das, IFS, Conservator of Forest (Dev), O/o Chief Conservator of Forest (RE & WP), Assam, submitted his enquiry report and findings vide his letter No. F4.69/RE&WP/enquiry report/Coal mining/405-06, dated 11th May, 2021. The enquiry report was forwarded to Delinquent officer for his representation vide letter FRE.82/2020/570, dated 3rd August, 2021. The written representation was submitted by the delinquent officer on 21st August, 2021.

Therefore, upon perusal of all charges framed, connected papers, documents etc. and hearing of the person concerned, the undersigned arrived upon conclusion which was very unambiguously stated in the enquiry report, reproduced as below-

- 1. The charge of "Failure to prevent gross violation of the Forest (Conservation) Act, 1980" is partially proved but not beyond doubt.
- 2. The charge of "Failure to discharge statutory duty of preventing commission of forest offence prescribed under Section 61 of the Assam Forest Regulation, 1891," could not be proved.
- 3. The charge of "Serious dereliction of Government duty resulting in massive illegal coal mining in forest area" is partially proved.

After careful examination of the findings of the Inquiry Officer, it reveals that out of the 3(three) charges, only charges No.1 and 3 are partially proved, while the other charge could not be proved by the Inquiry Officer. Therefore, the Governor of Assam in exercise of power conferred by the Rule 7 of the Assam Services (Discipline and Appeal) Rules, 1964 is pleased to conclude the proceeding drawn up against Shri Prafulla Chandra Lahkar, AFS, the then Forest Ranger, Lekhapani Range, Digboi Division, Digboi, with a minor penalty of Censure under Rule 7(i) of the Assam Services (Discipline and Appeal) Rules, 1964.

**Lett. No. PG. 22/70/P-II/1,** dated Shillong, the 2nd June, 1970 from the Chief Secretary to the Government of Assam to all Administrative Departments, all Head of Departments, All Deputy Commissioners and Sub-Divisional Officers.

**SUBJECT**:- Timely publication of Government Notifications and other important matters in the weekly Official Gazette.

I am directed to say that it has come to the notice of Government that important notification having bearing on statutes and matters of immediate public interest are sometimes published in the Official Gazette on date much later than prescribed. Government have decided, therefore, to introduce the following system with immediate effect, which must be strictly adhered to in sending notice to the Assam Government Press for publication in the Official Gazette.

1. In the first instance, it has to be noted that the printing of the weekly Gazette must be completed by the end of every Tuesday so that it may be duly published on every Wednesday.

- 2. Every notification and every other matter which is required to be printed and published in a particular issue of the Official Gazette must, therefore, reach the Director, Assam Government Press on the Monday of the week preceding the week in which it is required to be published. If this is not done it is infructuous requesting the Director, Assam Government Press to publish such notification or other matter in the next issue of the Gazette, the expression usually inserted in all endorsements made to the Director.
- 3. Wherever it is necessary to print and publish a notification on a specified date (excluding such Notification or communicate as are to be published in Gazette extraordinary) clear instruction of that effect must be given to the Director, Assam Government Press, both on the body of such notification within the indication at the top in the red ink and is a separate covering.
- 4. To achieve the objective in papers 2 and 3, it is essential that proper discretion should be exercised by the concerned officers in the Department or office and all matters for publication in the Gazette should scrutinised and sent to the Press after careful application.
- 5. As for publication of any matters in a Gazette, Extraordinary, the existing procedure whereby the prior approval of the General Administration Department is to be obtained will continue.
