## OFFICE ORDER

NO.GAG(B) 282/2011/63.- Whereas, the Departmentally Related Standing Committee (DRSC), Assam legislative Assembly, Dispur in its meeting with the General Administration Department, Government of Assam held on 14/03/2020 had expressed serious concern over the issue of undue reservation of rooms for the VIPs/other dignitaries and occupation of such rooms by officers in different Circuit Houses of the districts and sub-divisions for months together causing great inconveniences in smooth functioning/ management of the Circuit Houses and the interest of the public.

Whereas, in the interest of the public and to stop these malpractices , it has been decided that no room should be kept reserved in the Circuit Houses in the districts and sub-divisions except those for the Hon'ble Governor , Assam and Hon'ble Chief Minister, Assam from now onwards.

Further, no officer on transfer at the district and sub-divisional level should be allowed to occupy rooms in the Circuit Houses more than 15 (fifteen) days under any circumstances.

The Deputy Commissioners and Sub-divisional Officers are hereby instructed to adhere to the above arrangements and ensure strict compliance of this order .

This will come into force with immediate effect.
