ORDER

The 29th April, 2022

No. SWD.224/2020/170.- Whereas, the office of the Chief Judicial Magistrate, Kokrajhar vide letter No. KJM- 48/2020/593 dated 16th July, 2020 informed the Social Welfare Department about a complaint against Smti. Kanan Basumatary, Member (Social Worker) of the Juvenile Justice Board (JJB), Kokrajhar. The matter relates to the fact that Shri Hantigiri Narzary, Member, JJB, Kokrajhar, lodged an FIR stating that there is a case being Kokrajhar PS Case No. 285/2020. u/s. 376/(A) (B) of IPC r/w Section 4 of POCSO Act in respect of a Child-in-Conflict with Law (CCL) on 2nd July, 2020 at 7.30 PM. in the said case, the CCL was produced before the JJB, Kokrajhar on 06.06.2020 and the learned Principal Magistrate, JJB, Kokrajhar sent the CCL to Observation Home, Boko considering the nature and gravity of the offences.

But, on 20.06.2020 the said CCL was released on bail by Smti. Kanan Basumatary, the other Member of the JJB, Kokrajhar without either informing the complainant or the Learned Principal Magistrate and moreover, without following the due process of law.

The learned Principal Magistrate came to know about the matter on 23.06.2020 and that the order for bail / zimma dated 20th June, 2020 was prepared by Sri Arunabh Deb Sharma, Dealing Assistant of the JJB, Kokrajhar and he obtained the signature of the Member, Smti. Kanan Basumatary without the knowledge and instruction of the learned Principal Magistrate. Then learned Principal Magistrate observed vide Order dated 23rd June, 2020 that some questionable dealing has taken place between the Dealing Assistant, Member, JJB and the parties and that the bail order was illegally pronounced. The Principal Magistrate called for a sitting of the Board on 29.06.2020 and in that sitting of the Board, the bail/ zimma order dated 20.06.2020 was revoked.

The Principal Magistrate observed that the bail order was illegally prepared by the said Dealing Assistant without his knowledge and that there is some foul play which required a thorough enquiry. It is strongly suspected that the bail order was prepared and passed with the connivance of the Dealing Assistant, Sri Arunabh Deb Sharma, Advocate, Sri Narayan Sarkar, Mohori, Dildar Ali, the parties and Smti. Kanan Basumatary, Member, JJB, Kokrajhar. The Principal Magistrate further observed that there was every scope of exchange of money between the above-mentioned persons in lieu of the bail order.

Thereafter, during the course of hearing of the case, Smti. Kanan Basumatary stated that the Dealing Assistant asked her to come to office and thereafter the Dealing Assistant asked her to sign the order granting bail to the CCL and she signed accordingly.

As stated by the Principal Magistrate, JJB, Kokrajhar, it was an illegal order and that only the Principal Magistrate is empowered to issue bail.

Having regard to the above and in view of the fact Smti. Kanan Basumatary, Member, JJB, Kokrajhar acted in a purportedly malafide manner, without the approval of the Principal Magistrate, an enquiry was ordered into the matter through the Deputy Commissioner, Kokrajhar, as laid down under Section 4(7) of the Juvenile Justice (Care and Protection of Children) Act, 2015.

Accordingly, vide letter No. SWD.224/2020/139 dated 19.2.2021, the Deputy Commissioner, Kokrajhar was requested to enquire into the matter and submit a report. Thereafter, the Deputy Commissioner

conducted an enquiry through Smti. Kalyani Kangkona Das, Assistant Commissioner, Kokrajhar, who subsequently, submitted her report to the Deputy Commissioner, Kokrajhar. Accordingly, the Deputy Commissioner, Kokrajhar vide letter No. KAA.130/2020/193 dated 21st May, 2021 submitted the enquiry report to the Government. The Enquiry Officer, after a thorough enquiry into the matter, came to the conclusion that, "it is evident that Smti. Kanan Basumatary is negligent and casual towards her duty and that the allegation against her of professional misconduct in office pertaining to a sensitive case is found to be true".

After perusal of the enquiry report, the Govt. of Assam has come to the conclusion that Smti. Kanan Basumatary, by signing the said bail order has not only exceeded her jurisdiction but is also found guilty of misuse of power vested under the Juvenile Justice (Care & Protection of Children) Act, 2015 which has caused serious mishandling of a sensitive case, which not only involves Section 376(A) of the IPC but also Section 4 of the POCSO Act, 2012. Accordingly, the Government of Assam has decided to accept the findings of the Enquiry report submitted by the Deputy Commissioner, Kokrajhar together with the views of the Learned Principal Magistrate, JJB, Kokrajhar.

Therefore, the Governor of Assam, in exercise of the powers conferred under Section 4(7)(i) of Juvenile Justice (Care & Protection of Children) Act, 2015, is pleased to terminate the services of Smti. Kanan Basumatary, Member of the Juvenile Justice Board, Kokrajhar, with immediate effect.
