#### The 12th May, 2023

**No. FRE.81/2020/229.-** Whereas, a departmental proceeding was drawn up against Sri Shantanu Baruah, AFS, the then Forest Ranger, Lekhapani Range, under Digboi Division, Digboi and a show cause notice was issued vide Letter No. FRE.81/2020/40, dated 10th September, 2020 along with Statement of Allegation of charges, List of Exhibits to Shri Shantanu Baruah in respect of the following charges:

- 1. Charge No.1 : Failure to prevent gross violation of the Forest (Conservation) Act, 1980 .
- 2. Charge No.2 : Failure to discharge statutory duty of preventing commission of forest offence prescribed under Section 61 of the Assam Forest Regulation, 1891.
- 3. Serious dereliction of Government duty resulting in massive illegal coal mining in forest area.

The defence statement submitted by the delinquent officer has been received in the Department on 2nd January, 2021.

Whereas, on being not satisfied with the defence statement submitted by the Delinquent Officer, the Environment & Forests Department instituted a Departmental enquiry by appointment of a Presenting officer vide Letter No. FRE.81/2020/73-A, dated 16th February, 2021 and Inquiry Officers vide Letter No. FRE.81/2020/73, dated 16th Feb, 2021.

Whereas, the enquiry officer, Dr. Vinay Gupta, IFS, Addl. Principal Chief Conservator of Forest (State Inquiry Officer), O/o Principal Chief Conservator of Forest & Head of Forest Force, Assam, submitted his enquiry report and findings vide his letter No.PF/DP/Shantanu Baruah, dated 7th December, 2021.

Therefore, upon perusal of all charges framed, connected papers, documents etc. and hearing of the person concerned, the undersigned arrived upon conclusion which was very unambiguously stated in the enquiry report, reproduced as below-

- The charge of "Failure to prevent gross violation of the Forest (Conservation) Act, 1980" is not proved.
- 2. The charge of "Failure to discharge statutory duty of preventing commission of forest offence prescribed under Section 61 of the Assam Forest Regulation, 1891," could not be proved.
- 3. The charge of "Serious dereliction of Government duty resulting in massive illegal coal mining in forest area" could not be proved.

After careful examination of the findings of the Inquiry Officer, it reveals that out of the 3(three) charges, all the 3 (three) charges could not be proved or established by the Inquiry Officer. Therefore, the Governor of Assam in exercise of power conferred by the Rule 7 of the Assam Services (Discipline and Appeal) Rules, 1964 is pleased to exonerate from all charges leveled against Shri Shantanu Baruah, the then Forest Ranger, Lekhapani Range, under Digboi Division, Digboi.
