## NOTIFICATION

The 27th April, 2020

**No. TAD/BTC/250/2020/30.-** Whereas the State Election Commission had declared holding of election in BTC vide Notification No. SEC.146/2019/92 dated : 11-03-2020 and whereas the election in BTC was deferred indefinitely vide State Election Commission's letter No. SEC.146/2019/117 dated: 20-03-2020.

And whereas the Governor of Assam is satisfied that a situation has arisen in which the administration of the Bodoland Territorial Area Districts cannot be carried on in accordance with the provisions of the Sixth Schedule to the Constitution of India.

Now, therefore, the Governor of Assam, in exercise of the powers conferred by sub-paragraph (2) of paragraph 16 of the Sixth Schedule to the Constitution of India, is pleased-

- to assume to himself, with immediate effect, the administration of the said Districts and all functions and powers vested in or exercisable by the Bodoland Territorial Council,
- to declare that all functions and powers vested in or exercisable by the aforesaid Council, the Executive committee, Chief Executive Member, Deputy Chief Executive Member, Speaker, Deputy Speaker and Executive Members of the aforesaid Council under the Sixth Schedule or any law in force in the said Districts shall, subject to his superintendence, direction and control, be exercised by such persons or authority as the Governor may be Notification appoint in this behalf,

(c) to direct that during the period of operation of this order (i) all reference in the Sixth Schedule or in any law, rules, Regulations or Orders to the Council shall in relation to the said districts, insofar as it relates to the functions and powers vested in or exercisable by the Council be constructed unless the context otherwise requires, as reference to the Governor of Assam and references in any Laws, Rules, Regulations or order in force in that District to the "Executive Committee", "Chief Executive Member", "Deputy Chief Executive Member", "Speaker", "Deputy Speaker", or "Executive Member", be construed, unless the context otherwise requires, as reference to such person or authority referred to in paragraph (b) of this order.

This order shall take immediate effect and shall, unless terminated earlier or extended further, remains in force for a period of six months.
