NOTIFICATION

No. ASE 135/2016/Pt/45 .- In exercise of the powers conferred by the proviso to sub-section (1) of section 31 of the Assam Non-Government Educational Institutions (Regulation and Management) Act, 2006 (Assam Act No. IV of 2007), the Governor of Assam is hereby pleased to make the following rules further to amend the Assam Non-Government Educational Institutions (Regulation and Management) Rules, 2007, hereinafter referred to as principal Rules, namely :-

Short title and commencement	1.	(1)	These Rules may be called the Assam Non-Government Educational Institutions (Regulation and Management) (Amendment) Rules, 2020.
		(2)	They shall come into force on the date of their publication in the Official Gazette.
Amendment of rule 3	2.		In the Principal Rules, in rule 3,-
		(i)	in sub-rule (1), in the second line, in between the words "Director" and "in", the word "online" shall be inserted;
		(ii)	after sub-rule (2), the following new sub-rule (3) shall be inserted, namely :-

- “(3) (a) The Director, on receipt of the application for Prior Permission online, shall forward the application to the Inspector of Schools within 5 working days from the date of receipt of the application for causing an enquiry and submission of report thereof.
- (b) The Inspector of Schools shall forward the application along with the Enquiry Report online, regarding Prior Permission to the Director within 5 working days from the date of completion of the enquiry.
- (c) The Inspector of Schools shall complete the enquiry process within 21 working days from the date of receipt of the application from the Director.
- (d) The Director shall grant Prior Permission within 15 working days from the date of receipt of the Enquiry Report from the Inspector of Schools and then communicate to the applicant.
- (e) In case of refusal by the Director to grant Prior Permission, the same shall be communicated to the applicant within 15 working days from the date of issue of the order stating the reasons of refusal in writing.”

Amendment of rule 4

3.

In the Principal Rules, in rule 4, in sub-rule (1):-

- (i) in clause (a), in the third line, in between the words “application” and “for”, the word “online” shall be inserted;
- (ii) after clause (a), for the existing clause (b), the following clause (b) shall be substituted and thereafter the following new clauses (c), (d),(e), (f) and (g) respectively, shall be inserted, namely:-

“(b) The Director, on receipt of the application for administrative recognition online, shall forward the application to the Inspector of Schools within 5 working days from the date of receipt of the application, for causing an enquiry and submission of report thereof.

(c) The Inspector of Schools shall complete the enquiry within 21 working days and furnish the Enquiry Report to the Director within 5 working days from the date of completion of the enquiry.

(d) After receipt of the Enquiry Report, within 15 working days from the date of its receipt, the Director shall submit the report to the

Administrative Recognition Committee constituted under section 7 of the Act for registering the newly established Non-Governmental educational institutions.

- (e) The Director, on receipt of the recommendation of the Administrative Recognition Committee, shall issue order either granting or refusing to grant the administrative recognition and shall accordingly communicate to the applicant within 15 working days from the date of issue of the order.
- (f) In case of refusal to grant administrative recognition, the Director shall state the reasons for doing so in writing to the applicant in the communication required to be made to him under clause (e) above within 15 working days from the date of issue of the order.
- (g) In case of grant of administrative recognition, the Director shall communicate the Registration Number to the applicant/Management Committee of the concerned school within 15 working days from the date of issue of the order under clause (e) above.”

Amendment of rule 6

4.

In the Principal Rules, in rule 6, in sub-rule (1) , -

- (i) in clause (a), in between the word “institution” and the punctuation mark “;” appearing at the end, the words and figure, “within 15 working days from the date of receipt of the application online” shall be inserted ;
- (ii) for existing clause (b), the following clause (b) shall be substituted and thereafter the following new clauses (c), (d) and (e) shall be inserted, namely :-
 - “(b) On receipt of order from the Director, the Inspecting Officer or an authorized officer not below the rank of Deputy Director shall prepare and furnish the Inspection Report within 21 working days from the date of receipt of the order from the Director in Form IV for consideration of the Director.
 - (c) The Director, within 15 working days from the date of receipt of the report, shall place the Inspection Report before the Administrative Recognition Committee along with other relevant documents for consideration of administrative recognition and final registration of the institute under section 6 of the Act.

- (d) The Director, on receipt of the recommendation of the Administrative Recognition Committee, shall issue order either granting or refusing to grant the administrative recognition to the applicant within 15 working days from the date of receipt of the administrative recommendation of the Committee and shall accordingly communicate to the applicant within 15 working days from the date of issue of the order.
- (e) In case of refusal to grant the administrative recognition, the Director shall state the reasons for doing so in writing to the applicant in the communication required to be made to him under clause (d) above within 15 working days from the date of issue of the order.”
