In response to this Department's letter No. UDD(M)151/2009/313 dated 11.04.2019, the Chairperson, Dibrugarh Municipal Board has submitted her reply to this Department vide her letter No. DM/EST/01/2015/1165-67 dated 08.07.2019. and her replies were not found to be satisfactory. Hence Smti. Soma Chakraborty, the Chairperson of Dibrugarh Municipal Board was asked to appear in person before the Secretary to the Government of Assam, Urban Development Department, Dispur, Guwahati-6 for a hearing on 04.11.2019 to give the Board an opportunity of being heard as per the provision of the Assam Municipal Act, 1956 vide Department's letter No. UDD(M)151/2009/355 dated 24.10.2019.

Accordingly, Smti. Chakraborty, Chairperson, Dibrugarh Municipal Board appeared in person and a statement on oath was taken where she admitted that the charges were true.

In view of the facts stated above, it is seen that Dibrugarh Municipal Board has persistently failed to perform its duties and responsibilities to the satisfaction of all concerned and therefore, the Governor of Assam, in exercise of his powers under Section 298 of the Assam Municipal Act, 1956 is pleased to dissolve Dibrugarh Municipal Board with immediate effect and direct the Deputy Commissioner, Dibrugarh to take the charge of the said Municipal Board immediately.

No.IPRD.30/2011/254.- Whereas, Sri R. Gogoi has been placed under suspension vide notification No.IPRD.107/2017/246, dtd.14/11/2017 w.e.f. 07/11/2017, the date of his arrest in connection with vigilance SP Case No.08/17. After the report/consent received from Inspector General of Police, CM's Special Vigilance Cell in regards to sharing of enquiry report, Departmental Proceeding against Shri R. Gogoi and other accused has been initiated. The Judicial Department has also advised to review the suspension of the charged officer and thereafter passed a Reason Order extending the suspension order by stating the grounds and the review exercise is to be carried out every three months and a decision either to lift or continue the suspension must be taken upon due application of mind on each occasion. Accordingly, the suspension of Sri Ranjit Gogoi was reviewed and decided to continue the suspension of Sri Gogoi vide Govt. Order No. IPRD.30/2011/253 Dated Dispur, the 27th August, 2019 ; and

Whereas, after due consideration of all facts and circumstances relating to this matter it is seen that the DP drawn up against Shri R. Gogoi is yet to come to its logical conclusion. The entire Departmental Proceeding against the charged officer is based on official records pertaining to the office Shri R. Gogoi held before the suspension and the period of his incumbency as DIPR. All the relevant documents containing evidence against Shri R. Gogoi is in public domain and is accessible by officer of the DIPR. Thus, it is considered expedient to ensure that confidentiality of the relevant document and ensuring measures to avoid any tempering what so ever is prime important for judicious objective and fact based conclusion of Departmental Proceeding instituted ; and

Whereas, re-instatement of charged officer may influence such material witnesses which will result in less than judicious and objective conclusion of the matter. Further, intimidation or coercion of witnesses against the charged officer also cannot be ruled out ; and

Whereas, on careful examination it is decided that Shri R. Gogoi may not be re-instated in service till such time as the Departmental Proceeding drawn up against him is brought to logical conclusion.

1. The Committee shall scrutinize the application/s and to approve the deserving proposals to issuance of Eligibility Certificate for all the fiscal and tax incentives under the policy. The Committee also scrutinizes and approved the proposals for fiscal incentives.
2. The Committee shall meet as and when necessary an at least once in a quarter.
3. The Chairman of the Committee may co-opt any expert/s, Officer for specific proposals.
4. At least five members including Chairman, Member Secretary and Commissioner Taxes shall be necessary for any sitting of the committee.
5. The Member Secretary shall submit a report to the Government about the holding of meeting/s.
