Subject : Constitution of a Committee to examine and understand the Govt. of India Best Practices for replication in the state of Assam-Preparation of framework and roadmap for implementation of (i) Online Application Receipt systems for selection of candidates by Public Enterprises Selection Board for the position of Managing Directors, General Manager and other positions as per Public Enterprises Policy, 2019 in State PSEs and (ii) Online Performance Appraisal and Review (PAR) System for the employees of the State PSEs towards improving the performance of Assam PSEs.

Assam has 38 numbers of functional State Public Sector Enterprises of which (i) 7 PSEs are profit making with up-to-date audited Annual Accounts, (ii) 11 PSEs are profit making with arrear in finalization of audited accounts, (iii) 2 PSEs are loss making but having up-to-date audited accounts and (iv) 19 PSEs are loss making with arrear in finalization of audited accounts.

This suggests the need for taking a number of initiatives for improving their performance. Two such initiatives being considered are (i) expeditious filling up of senior positions through online system which otherwise is taking more than one year in the present manual system seriously affecting PSE operations and (ii) proper performance appraisal of the employees for an efficient and effective Human Resource Management for improved performance with accountability.

In this context, Public Enterprises Department, Govt of Assam proposes to study GOI best practices and explore the possibility (i) to adopt the Online Application System on the lines of PESB, DPE, Govt of India for selection of the candidates for the positions of Managing Directors, General Managers and other positions as per Public Enterprises Policy, 2019 in State PSEs and other related statute and (ii) to adopt Online Performance Appraisal and Review (PAR) System for the employees of the State PSEs on the lines of PAR System in the CPSEs , Govt. of India.

In this connection a Committee under the Chairmanship of the Secretary , Public Enterprises Department is hereby constituted with the following members for critical study of GOI best practices and for the preparation of framework and roadmap for implementation of (i) Online Application Receipt systems for selection of candidates by Public Enterprises Selection Board for the position of Managing Directors, General Managers and other positions on the lines of PESB, DPE, Govt. of India and (ii) Online PAR System for the employees of the State PSEs.

1. To examine & understand Govt. of India Systems on PESB and CPSE PAR , both by studying the Govt. of India DPE and PESB Websites and by interaction with the concerned Gol officers and CPSEs.
2. To receive valuable and critical inputs from Assam PSEs on the subject and their consideration in preparing the report and in developing proper framework appropriate to Assam PSEs.
3. To suggest the best suitable framework for Public Enterprises Selection Board of Assam retaining existing composition and statutory requirements with a roadmap for implementation of the system for PESB, Assam.
4. To suggest best suitable framework for implementation of the PAR system in the State PSEs on the line of CPSE.

Terms of office:

The Chairman, Vice-Chairman and Members of the Sub Divisional ST Development Board shall hold their position in the board at the pleasure of the State Govt. The State Govt. may change the Chairman/Vice-chairman/Member of the board at any time. Moreover, the term of office of the board shall not exceed 3 years.

Function of the Boards:
