Whereas, Smti. Jahnabi Kalita was issued show cause notice vide letter No. HLA.229799/63 dated 10th November, 2022, charging the delinquent officer with gross misconduct and violation of Rule 3(1)(i), 3(1)(ii) and 3(1)(iii) of the Assam Civil Services (Conduct) Rules, 1965;

Whereas, Smti. Jahnabi Kalita, vide letter dated 25th November, 2022, submitted her written statement in defence explaining the circumstances of the case, wherein the officer denied all the charges framed against her;

Whereas, after careful examination of the written statement in defence submitted by Smti. Jahnabi Kalita and the materials on record, it was considered to get the charges enquired into by an Inquiry Officer with Presenting Officer;

Whereas, the Inquiry Officer, after conducting the Disciplinary Proceedings, submitted the Inquiry Report vide letter dated 2nd May, 2023, wherein it was concluded that the charges of gross misconduct and violation of Rule 3(1)(i), 3(1)(ii) and 3(1)(iii) of the Assam Civil Services (Conduct) Rules, 1965 are well established;

Whereas, after perusal of the Inquiry Report and the materials on record, the Government of Assam in Health & Family Welfare Department, decided to inflict the penalty of withholding of one increment without cumulative effect upon the delinquent officer under Rule 7(ii) of the Assam Services (Discipline and Appeal) Rules, 1964;

Whereas, the Inquiry Report was furnished to Smti. Jahnabi Kalita vide letter No.229799/117 dated 4th July, 2023 thereby giving her the opportunity of submission of representation, if any;

Whereas, Smti. Jahnabi Kalita submitted her representation vide letter dated 7th July, 2023, expressing her disagreement with the findings of the Inquiry Officer in the Inquiry Report;

Whereas, on examination, it was found that the representation of Smti. Jahnabi Kalita did not contain any new facts which warranted review of the Inquiry Report or the Disciplinary Proceeding;

Now, therefore, the Government of Assam in Health & Family Welfare hereby imposes the penalty of withholding of one increment without cumulative effect upon Smti. Jahnabi Kalita, under Rule 7 (ii) of the Assam Service (Discipline & Appeal) Rules, 1964.

SUBJECT :- Timely publication of Government Notifications and other important matters in the weekly Official Gazette.

I am directed to say that it has come to the notice of Government that important notification having bearing on statutes and matters of immediate public interest are sometimes published in the Official Gazette on date much later than prescribed. Government have decided, therefore, to introduce the following system with immediate effect, which must be strictly adhered to in sending notice to the Assam Government Press for publication in the Official Gazette.

1. In the first instance, it has to be noted that the printing of the weekly Gazette must be completed by the end of every Tuesday so that it may be duly published on every Wednesday.

2. Every notification and every other matter which is required to be printed and published in a particular issue of the Official Gazette must, therefore, reach the Director, Assam Government Press on the Monday of the week preceding the week in which it is required to be published. If this is not done it is infructuous requesting the Director, Assam Government Press to publish such notification or other matter in the next issue of the Gazette, the expression usually inserted in all endorsements made to the Director.

3. Wherever it is necessary to print and publish a notification on a specified date (excluding such Notification or communicate as are to be published in Gazette extraordinary) clear instruction of that effect must be given to the Director, Assam Government Press, both on the body of such notification within the indication at the top in the red ink and is a separate covering.

4. To achieve the objective in papers 2 and 3, it is essential that proper discretion should be exercised by the concerned officers in the Department or office and all matters for publication in the Gazette should scrutinised and sent to the Press after careful application.
