No.GDD.61/2004/131.-In exercise of powers conferred by Sec-5(1) (b) and sub-Section 12 of Guwahati Metropolitan Development Authority Act, 1985 (Assam Act No. XVI of 2011) as amended, Shri Abdul Mannan Faruk is hereby allowed to continue as Deputy Chairman, Guwahati Metropolitan Development Authority (GMDA) for a period of 03 (three) years from the date of nomination i.e. 17.03.2020 or until further orders.

As per provisions of Sub-section 5(I) of the GMDA Act, 1985, "the Chairman and Deputy Chairman [nominated under the provision to clause (b) of sub-section 5] shall hold office for a period of three years from the date of their nomination as Chairman or Deputy Chairman, as the case may be: Provided that after the expiry of the period of his appointment a person shall be eligible for re-appointment as Chairman or Deputy Chairman as the case may be"

Also, as per the order of the Hon'ble Chief Minister vide U.O. No.CMO.14/2020/1369 dated 17.03.2020, "in case the term of the Chairpersons and Vice-Chairpersons of various Corporations, Councils, Boards etc. appointed in pursuance of my U.O. No. CMO.14/2017/1447 dtd. 4th March, 2017 has expired, they may be allowed to continue temporarily until further orders."

Shri Abdul Mannan Faruk, Deputy Chairman may continue upto a maximum period upto 16.03.2023 since Sub-section 12 of Section 5 (I) of the GMDA Act, 1985, which also provides that *no person shall be appointed as Chairman or Deputy Chairman for more than two consecutive terms.*

However, since the appointment is until further orders, he may be removed at any time by further order of the Government and if there are no further orders, his term shall come to an end on 16.03.2023.

It is hereby also clarified that Shri Abdul Mannan Faruk's earlier term came to an end on 08.03.2020 as per provisions of Sub-section 12 of Section 5(I) of GMDA Act, 1985.

The earlier Notification issued vide No.GDD.61/2004/130 dated 05.05.2020 stands cancelled.

ORDER

The 5th June, 2020

No. IPRD.30/2011/256.- Whereas, Sri Ranjit Gogoi was placed under suspension vide notification No.IPRD.107/2017/246, dtd.14/11/2017 w.e.f. 07/11/2017, the date of his arrest in connection with vigilance SP Case No.08/17. On receipt of the report/consent from Inspector General of Police, CM's Special Vigilance Cell in regards to sharing of enquiry report, Departmental Proceeding was initiated against Sri Ranjit Gogoi and other accused. The Judicial Department has also advised to review the suspension of the charged officer and thereafter passed a Reason Order extending the suspension order by stating the grounds and the review exercise is to be carried out every three (3) months and a decision either to lift or continue the suspension must be taken upon due application of mind on each occasion. Accordingly, the suspension of Sri Ranjit Gogoi was reviewed and decided to continue the suspension of Sri Ranjit Gogoi vide Govt. Order No. IPRD.30/2011/255, Dated Dispur, the 5th March, 2020; and

Whereas, after due consideration of all facts and circumstances relating to this matter it is seen that the Departmental Proceeding drawn up against Sri Ranjit Gogoi is yet to come to its logical conclusion. The entire Departmental Proceeding against the charged officer was based on official records pertaining to the office Sri Ranjit Gogoi held before the suspension and the period of his incumbency as Director of Information & Public Relations. All the relevant documents containing evidence against Sri Ranjit Gogoi is in public domain and is accessible by office of the Director of Information & Public Relations. Thus, it is considered expedient to ensure that confidentiality of the relevant document and ensuring measures to avoid any tempering what so ever is prime important for judicious objective and fact based conclusion of Departmental Proceeding instituted; and

Whereas, re-instatement of charged officer may influence such material witnesses which will result in less than judicious and objective conclusion of the matter. Further, intimidation or coercion of witnesses against the charged officer also cannot be ruled out; and

Therefore, after careful examination of the case, the Governor of Assam is pleased to decide that Sri Ranjit Gogoi may not be re-instated in service till such time as the Departmental Proceeding drawn up against him is brought to its logical conclusion.
