The terms of reference are as follows:

- To advise the state Government on measures to prevent unnecessary pain or suffering of animal generally and more particular when they are being transported from one place to another or when they are used as performing animals or when they are kept in captivity or confinement.
- To advise the Government or any local authority or other person on improvements in the design of vehicles to lessen the urban or draught animals.
- To take all such steps for amelioration of animals by encouraging the construction of sheds, water-trougts and like and by providing for Veterinary assistance to animals.

- d. To advise the Government or any local authority or other person in the design of slaughter-houses or in connection with slaughter of animals so that necessary pain or suffering, whether physical or mental is eliminated in the pre-slaughter stages as far as possible and animals are killed, wherever necessary in as humane manner as possible.
- e. To take all such steps to ensure that unwanted animals are destroyed by local authorities whenever it is necessary to do so instantaneously or after being rendered insensible to pain or suffering.
- f. To encourage the formation or establishment of pinjrapoles, rescue homes, animals shelters and like where animals are animals and bird may find a shelter.
- g. To cooperate with the works of association established for the purpose of preventing unnecessary paying or suffering of animals.
- h. To encourage formation of animal welfare organization in any local area and to guide them in their working.
- i. To advise the Government matters relating to medical care and attention which may be provided in animal hospitals.
- j. To advise the Government on any matter connected with animal welfare or the prevention of infliction of unnecessary pain or suffering on animals.

[Attention of all officers ending matters for publication in the Assam Gazette is drawn to the following Government circular with the request that instructions contained therein may kindly be strictly adhered the orders to avoid delay in publication of Notification in the Assam Gazette :-]

Let. No. PG. 22/70/P-II/1, dated Shillong, the 2nd June, 1970 from the Chief Secretary to the Government of Assam to all Administrative Departments, all Head of Departments, All Deputy Commissioners and Subdivisional Officers.

SUBJECT :- Timely publication of Government Notifications and other important matters in the weekly Official Gazette.

I am directed to say that it has come to the notice of Government that important notification having bearing on statutes and matters of immediate public interest are sometimes published in the Official Gazette on date much later than prescribed. Government have decided, therefore, to introduce the following system with immediate effect, which must be strictly adhered to in sending notice to the Assam Government Press for publication in the official Gazette.

1. In the first instance, it has to be noted that the printing of the weekly Gazette must be completed by the end of every Tuesday so that it may be duly published on every Wednesday.

2. Every notification and every other matter which is required to be printed and published in a particular issue of the Official Gazette must, therefore, reach the Director, Assam Government Press on the Monday of the week preceding the week in which it is required to be published. If this is not done it is infructuous requesting the Director, Assam Government Press to publish such notification or other matter in the next issue of the Gazette, the expression usually inserted in all endorsements made to the Director.

3. Wherever it is necessary to print and publish a notification on a specified date (excluding such Notification or communicate as are to be published in Gazette extraordinary) clear instruction of that effect must be given to the Director, Assam Government Press, both on the body of such notification within the indication at the top in the red ink and is a separate covering.

4. To achieve the objective in papers 2 and 3, it is essential that proper discretion should be exercised by the concerned officers in the Department or office and all matters for publication in the Gazette should scrutinised and sent to the Press after careful application.

5. As for publication of any matters in a Gazette, Extraordinary, the existing procedure whereby the prior approval of the General Administration Department is to be obtained will continue.

I am to request you to acknowledge the receipt of this letter and confirmed that the instructions have been duly voted. If you have suggestion on this behalf they may please be communicated.
