**No. AEE.12/2023/197.-** In pursuance of Order of the Hon'ble Gauhati Court dated 2nd September, 2022 passed in WP(C) 5761/2022(Md. Taj Uddin Laskar vs SoA) and dated 12th March, 2021 passed in WP(C) 1667/2021(Eusob Ali Sheikh vs SoA), a fresh Gradation List in respect of cadre of Senior Lecturer of District Institute of Education and Training (DIET) in Assam was published vide Government Notification No AEE 12/2023/18 dated 18th March, 2023;

In view of submission of objections by some incumbents in the objections regarding their grievances for omission and commission requesting modification of their place of seniority, a hearing was held on 28th March, 2023 wherein the provision of existing rules for fixation of seniority in case of candidates selected/recommended by the Assam Public Service Commission were referred to;

After careful consideration of Government policy on seniority of candidates recommended by the Assam Public Service Commission, rule 21 of the Assam District Institute of Education and Training (DIET) Service Rules, 2010 together with other aspects, it has been decided to fix the inter-se seniority amongst the incumbents appointed on recommendation of the Assam Public Service Commission for preparation and finalization of the Gradation List for the post of senior Lecturer in District Institute of Education and Training as stated below:

- 1. The seniority of candidates selected in one batch on the recommendation of the Commission shall be fixed according to their order in the merit list if they joined their appointment within 15 days or on or before such date as extended by the competent authority;
- 2. If the candidates are appointed on the recommendation of the Commission in different batches, then the candidate who was recommended in earlier batch shall be senior to the candidate who was recommended in later batch:
- 3. If two or more candidates are bracketed in the merit list of the Commission, or two or more candidates are placed in same position/rank against different select list but recommended by the Commission at a time and the recommendation is also communicated by a single communication, the inter-se seniority of the candidates shall be determined according to the date of birth. To illustrate, if Mr. A has been selected as Lecturer in Mathematics and his name has been placed at 1 st position (topped the list for Mathematics) and similarly Mr. B has been selected as Lecturer in Education and his name has also been placed at 1st position (topped the list for Education) in a select list communicated by the Commission in single common letter, in this case the inter-se seniority of the candidates shall be determined according to the date of birth.
- 4. The above criteria shall be taken into consideration in case the appointment of the candidate is made during the year of recommendation by the Commission and against the existing vacancies at the time of recommendation. In case of the appointment is made in subsequent year against any resultant vacancies, the inter-se seniority shall be fixed considering their recommendation in subsequent batch in the year of appointment.

With the above criteria of fixation of inter-se seniority, the Governor of Assam is hereby pleased to notify the Final Gradation List of the Senior Lecturers of various District Institute of Education and Training in the State as enclosed herewith.

This will come into force with immediate effect.
