THE TERMS OF REFERENCE OF THE COMMITTEE ARE AS UNDER

- I. The Committee will monitor the implementation of relief programme in all the calamities affected Districts of Assam.
2. The SLIC may be convened for issuance of any clarification related to relief measures in the calamities affected Districts.
3. The SLIC may note that “the borrowers from MFIs registered under RBI should also be eligible for the incentives provided to borrowers of scheduled commercial banks and regional rural banks under the master directions issued by RBI”.
4. The Member- Secretary shall maintain all records of the meetings and provide the requisite follow ups, reports to the Committee.
