No. BTC/LR-382/2012/Pt.III/370. - Consequent upon notice served on pattadars vide the Secretariat Land Acquisition Notification No. BTC/LR-382/2012/Pt.III/356, dated 30th May, 2014, the BTC did not received any objection and complains in regard to fixation of the value of land at the rate of Rs. 8,00,000/- (Rupees Eight Lakhs) only per Bigha and other cost as well for the construction of NH, 2 Lane Road from Barama to Baska. Hence the BTC is pleased to finalise the value of land at the rate of Rs. 8,00,000/- per Bigha of the villages Chaukara and Dadhigaon. On the basis of the value fixed per Bigha land 30% of Solatium on market value of Land under section 23(1) and interest U/S-23 (1-A) of Land Acquisition Act. 1894 are added and calculated accordingly. The calculated Table below is self explanatory. This is partial modification of earlier notification No. BTC/LR-382/2012/Pt.III/357, dated 15th October, 2014.
