In the Gauhati High Court Criminal Rules & Orders Vol. - I Part - A Chapter 12 INVESTIGATION, the following shall be added after existing Rule 3:

#### "4. RECORDING OF STATEMENTS OF VICTIMS OF RAPE:

- i. Upon receipt of information relating to the commission of offence of rape, the investigating officer shall make immediate steps to take the victim to the jurisdictional Chief Judicial Magistrate for the purpose of recording her statement under Section 164 of the Cr.P.C.
- ii. On production of the victim before the jurisdictional Chief Judicial Magistrate, the Officer shall record the statement of the victim immediately or direct a Judicial Magistrate, preferably a lady Magistrate, to record such statement. A copy of the statement under Section 164 of the Cr.P.C. should be handed over to the investigating officer immediately with a specific direction that the contents of such statement under Section 164 of the Cr.P.C. should not be disclosed to any person till charge-sheet/report under Section 173 of the Cr. P.C. is filed.
- iii. The investigating officer shall record specifically the date and the time at which he learnt about the commission of the offence of rape and the date and time at which he took the victim to the jurisdictional Chief Judicial Magistrate as aforesaid.
- iv. If there is any delay exceeding 24 hours in taking the victim to the jurisdictional Chief Judicial Magistrate, the investigating officer should record the reasons for the same in the case diary and hand over a copy of the same to the Chief Judicial Magistrate.
- v. Medical examination of the victim: Section 164-A of the Cr.P.C. inserted by Act 25 of 2005 in the Cr.P.C. imposes an obligation on the part of investigating officer to get the victim of the rape immediately medically examined. A copy of the report of such medical examination should be immediately handed over to the office of the jurisdictional Chief Judicial Magistrate and thereafter, the office shall tag the same with the case record.
- vi. The right to receive a copy of the victim's statement by the accused will arise only after cognizance is taken and at the stage contemplated by Sections 207 and 208 of the Cr.P.C. and not before."
