Powers and responsibilities of the Chairperson:

The Chairperson shall exercise such powers and discharge such responsibilities as laid down and mandatory under Section-15 of the "Assam Biodiversity Rules, 2010" .

Function of the Secretary:

The Secretary of the Assam State Biodiversity Board shall perform such function as laid down and mandatory under section-II of the "Assam Biodiversity Rules, 2010".

Terms of Reference of the Assam State Bio-diversity Board:

1. The Activities of the Assam State Biodiversity Board shall be essential and strictly governed by the provisions of the Assam Biodiversity Rules, 2010.
2. The Assam State Biodiversity Board shall consult the National Bio-diversity Authority (NBA) and the Biodiversity Management Committees, as and when required, while taking decision relating to use of biological resources of the state and traditional knowledge associated with such resources.
3. The Assam State Biodiversity Board shall, in the discharge of its functions and responsibilities under the Assam Bio-diversity Rules, 2010 be bound by such direction on question of policy as the state Government may give of it writing from time to time under sub-sections (1) of Section-49 of the Biological Diversity Act, 2010. Provided that the Assam Biodiversity shall as far as practicable be given an opportunity to express its views before any direction is given under the said provision.
4. The Principal Chief Conservator of Forests (Biodiversity) will function as the Secretary of the Assam State Biodiversity Board.
5. The Assam State Biodiversity Board would from time to time as required.
6. TA/DA of non-official members would be born out of funds provided by the State Government for the purpose/State Biodiversity Fund. TA/DA of officials members would be borne by their respective parent Departments.

Let. No. PG. 22/70/P-II/1, dated Shillong, the 2nd June, 1970 from the Chief Secretary to the Government of Assam to all Administrative Departments, all Head of Departments, All Deputy Commissioners and Sub-Divisional Officers.

SUBJECT :- Timely publication of Government Notifications and other important matters in the weekly Official Gazette.

I am directed to say that it has come to the notice of Government that important notification having bearing on statutes and matters of immediate public interest are sometimes published in the Official Gazette on date much later than prescribed. Government have decided, therefore, to introduce the following system with immediate effect, which must be strictly adhered to in sending notice to the Assam Government Press for publication in the Official Gazette.

1. In the first instance, it has to be noted that the printing of the weekly Gazette must be completed by the end of every Tuesday so that it may be duly published on every Wednesday.

2. Every notification and every other matter which is required to be printed and published in a particular issue of the Official Gazette must, therefore, reach the Director, Assam Government Press on the Monday of the week preceding the week in which it is required to be published. If this is not done it is infructuous requesting the Director, Assam Government Press to publish such notification or other matter in the next issue of the Gazette, the expression usually inserted in all endorsements made to the Director.

3. Wherever it is necessary to print and publish a notification on a specified date (excluding such Notification or communicate as are to be published in Gazette extraordinary) clear instruction of that effect must be given to the Director, Assam Government Press, both on the body of such notification within the indication at the top in the red ink and is a separate covering.

4. To achieve the objective in papers 2 and 3, it is essential that proper discretion should be exercised by the concerned officers in the Department or office and all matters for publication in the Gazette should scrutinised and sent to the Press after careful application.

5. As for publication of any matters in a Gazette, Extraordinary, the existing procedure whereby the prior approval of the General Administration Department is to be obtained will continue.
