Accordingly, Shri Deep Pegu, the then Superintending Engineer, Sivasagar WR Circle (now Director Design, WR Department) was appointed as Inquiry Officer and Shri Diganta Sarma, the E.E., Jorhat WR Division was appointed as Presenting Officer vide notification No. WR(CON)2/2020/21 dtd. 25th September, 2020; and

Whereas, Shri Deep Pegu, Director Design, WR Department and the then Superintending Engineer, Sivasagar WR Circle cum Inquiry Officer has submitted his enquiry report vide letter No. SES/CON/21/2020/842 dated 18th December, 2020. The Inquiry Officer has found that the charges against Shri Jawaharlal Roy, AE.E. are partially established. The Inquiry officer has concluded his report with the following remarks.

"Therefore, based on the documentary evidence, circumstantial evidence and examination of the self-appraisals (both written and verbal) given by Shri Jawaharlal Roy, the findings leads to logical conclusion that there was some negligence to the duty by Mr Jawaharlal Roy, as it was established from the documentary evidence that he was absent from duty (from 2nd May, 2019 to 17th February, 2020 i.e. around 300 Days) without following established official procedure, Moreover, to till date, as no petition is submitted by the charged officer for the approval of regularization of his period of leave/absence to his duties which is also

tantamount to break of services as per govt rule. Therefore, some dereliction/negligence of Govt. duties is found during the inquiry."

Whereas, as per Rule 9(A) of the Assam Services (Discipline & Appeal) Rules, 1964 as amended, a copy of enquiry report was furnished to Shri Jawaharlal Roy and requested him to submit his representation (if any) on the report. In reply, Shri Jawaharlal Roy submitted his representation vide letter No. NIL dated 3rd April, 2021 where he denied the charges and the findings of the enquiry report; and

Whereas considering all aspects of the matter, complaint petition submitted by the then Executive Engineer, Upper Assam Investigation WR Division, W.R. Department, the reply of the D.O. Sri Jawaharlal Roy, AE.E. to the show-caused notice, enquiry report submitted by Shri Deep Pegu, the then Superintending Engineer, Sivasagar WR Circle (now Director Design, WR Department) cum Inquiry Officer and representation submitted by the D.O. Jawaharlal Roy, AE.E it was proposed to inflict punishment of withholding of 2 (two) increments without cumulative effect as prescribed in Rule 7 of the Assam Services (Discipline and Appeal) Rules, 1964 in respect of Shri Jawaharlal Roy, AE.E; and

Lett. No. PG. 22/70/P-II/1, dated Shillong, the 2nd June, 1970 from the Chief Secretary to the Government of Assam to all Administrative Departments, all Head of Departments, All Deputy Commissioners and Sub-Divisional Officers.

SUBJECT:- Timely publication of Government Notifications and other important matters in the weekly Official Gazette.

I am directed to say that it has come to the notice of Government that important notification having bearing on statutes and matters of immediate public interest are sometimes published in the Official Gazette on date much later than prescribed. Government have decided, therefore, to introduce the following system with immediate effect, which must be strictly adhered to in sending notice to the Assam Government Press for publication in the Official Gazette.

1. In the first instance, it has to be noted that the printing of the weekly Gazette must be completed by the end of every Tuesday so that it may be duly published on every Wednesday.

- 2. Every notification and every other matter which is required to be printed and published in a particular issue of the Official Gazette must, therefore, reach the Director, Assam Government Press on the Monday of the week preceding the week in which it is required to be published. If this is not done it is infructuous requesting the Director, Assam Government Press to publish such notification or other matter in the next issue of the Gazette, the expression usually inserted in all endorsements made to the Director.
- 3. Wherever it is necessary to print and publish a notification on a specified date (excluding such Notification or communicate as are to be published in Gazette extraordinary) clear instruction of that effect must be given to the Director, Assam Government Press, both on the body of such notification within the indication at the top in the red ink and is a separate covering.
- 4. To achieve the objective in papers 2 and 3, it is essential that proper discretion should be exercised by the concerned officers in the Department or office and all matters for publication in the Gazette should scrutinised and sent to the Press after careful application.
- 5. As for publication of any matters in a Gazette, Extraordinary, the existing procedure whereby the prior approval of the General Administration Department is to be obtained will continue.

I am to request you to acknowledge the receipt of this letter and confirmed that the instructions have been duly voted. If you have suggestion on this behalf they may please be communicated.
