Guidelines for selection of beneficiary:-

- 1. Only Tea and Ex-Tea Garden Tribes should be selected against submission of Tea Tribes Caste Certificates issued by competent authority or as may be satisfied to the authority.
- 2. Under one scheme, only one beneficiary in a family should be selected so that maximum member of beneficiary families may be covered (Not applicable for Scholarship).
- 3. Same beneficiary should not be selected for subsequent period so as to stop repetition and misuse of benefits under schemes of Tea Tribes Welfare Department (Not applicable for Scholarship).
- 4. While selecting beneficiaries preference should be given to young entrepreneurs/unemployed youths/widows/aged unmarried females/persons with disabilities/BPL status besides general status beneficiaries.

TA/DA of the Chairman and Members of the Committee:

The Chairman/Member who is the Member of Legislative Assembly is required to draw TA/DA for the journeys performed by him in connection with the meeting of the Selection Committee. They will draw TA/DA from the place where from they draw their salary, as mentioned in Government O.M. No.FM.69/74/13 dated:01.05.1976.
