## NOTIFICATION

**No.KRA. 1/FREMAA/Achalpara/2019/114.-** Whereas in the opinion of the Collector of Kamrup, it is expedient or necessary to acquire speedily the below mentioned schedule of land for implementing the works of "Assam Integrated Flood & Riverbank Erosion Risk Management Project for Gumi and its downstream area - Tranche-II" in connection with flood control and anti erosion measures, embankment and drainage;

Now, therefore, in pursuance of Section 9 of the Assam Land (Requisition & Acquisition) Act, 1964, the Collector of Kamrup is pleased to order that the land as scheduled below measuring **7(seven) Bigha – 1(one) Katha – 18(eighteen) Lecha** in the village **Achalpara Baghmara** under **Goroimari** Revenue Circle shall be acquired for the above purpose.
