No. BTC/LR-382/2012/Pl. IV/408. - Consequent upon notice served on pattadars vide the Secretariat Land Acquisition Notification No. BTC/LR-382/2012/Pl.IV/400, dated 5th June 2014, the BTC did not received any objection and complains in regard to fixation of the value of land at the rate of Rs. 6,80,000/-and Rs. 7,10,600/- per Bigha and other cost as well for the construction of NH, 2 Land Road from Barama to Baska. Hence the BTC is pleased to finalise the value of land at the rate of Rs. 6,80,000/-and Rs. 7,10,600/- per Bigha of villages Chaibari, Dhanbil and Allia. On the basis of the value fixed per Bigha land 30% of Solatium under section 23(2) & Interest U/S-23 (1-A) of Land Acquisition Act, 1894 are added and calculated accordingly. The calculated Table below is self explanatory. This is partial modification of earlier notification No. BTC/LR-382/2012/Pl.IV/400, dated 29th November, 2014.
