No. HMA.50/2018/353.- Whereas, a detailed report has been received from the Chief Minister's office regarding alleged rape and murder of a 13 (thirteen) year old minor girl under Dhula Police Station in Darrang District;

Whereas the victim was found dead in the house of one Shri Krishna Kamal Baruah, an SSB constable by profession;

Whereas, in spite of the fact that the body was found in a hanging condition, initially only a UD case was registered by the Police;

Whereas, the father of the deceased girl lodged an FIR stating that his daughter was murdered by accused Shri Krishna Kamal Baruah;

Whereas, the accused Shri Krishna Kamal Baruah was arrested but Police did not seek custody of the accused and the accused was forwarded to judicial custody;

Whereas, Shri Raj Mohan Ray, APS, Superintendent of Police, Darrang being the Head of District Police failed to supervise the incident regarding (i) whether photograph/ videography was taken or not (ii) whether the body was brought down without the presence of Magistrate and Police (iii) why only a UD case was registered and the accused was not arrested immediately (iv) why police custody was not sought for the accused Shri Krishna Kamal Baruah, (v) why custodial interrogation did not happen in the instant case, (vi) thumb impression of the father of the deceased girl was allegedly obtained by the Officer in Charge of Dhula P.S., under the supervision of Superintendent of Police, Darrang (vii) people from other villages allegedly tried to settle down the case in exchange of money.

Now, therefore, in the interest of public service, the Governor of Assam is satisfied that Shri Raj Mohan Ray, APS, Superintendent of Police, Darrang be placed under suspension for his gross negligence and dereliction duties with effect from 12th August, 2022 pending drawal of Departmental Proceedings.

Accordingly, the Governor of Assam is pleased to place Shri Raj Mohan Ray, APS, Superintendent of Police, Darrang under suspension under Rule 6(1) (a) of the Assam Services (Discipline & Appeal) Rules, 1964 with effect from 12th August, 2022.

Shri Raj Mohan Ray, APS, Superintendent of Police, Darrang is allowed to draw subsistence allowances as admissible under provision of F.R. 53 (1) (ii) (a) of the FRs & SRs subject to production of non-employment certificate under Sub Rule (2) of F.R. 53.

During the period of suspension, his Headquarters will be Assam Police Headquarters, Ulubari, Guwahati.
