**TRANSFER POLICY FOR THE STAFF OF THE SUBORDINATE
COURTS IN ASSAM**

1. The Policy shall be known as "Transfer Policy for the staff of the Subordinate Courts in Assam".
2. Unlike Judicial Officers, the transfer of employees of Subordinate Judiciary may not be done in a routine manner for the time being. It may be done in public interest and on the event of immediate necessity.
3. The transfer may be need based and in administrative exigency for the time being and may not be done in every three years as there is lack of infrastructure for residential accommodation for staff in every station.
4. The High Court may take necessary steps in due course to provide residential accommodation to staff in future, so that employees can be transferred like judicial officers in regular interval.
5. Since litigants come in contact first with the ministerial staff in courts, so every staff is required to maintain high standard of probity while discharging their functions. Any indication/appearance of impropriety may warrant transfer of a staff from one station to another for restoring confidence of the litigants in the system.
6. If transfer of an employee becomes inevitable then his/her place of posting may be considered at the nearest station of his hometown. This will reduce discontent to a great extent.
7. As far as practicable all transfers shall be given effect to in the month of January of the calendar year so that the children (Offspring) of the incumbents faces no difficulties in getting admission either in colleges or in the schools.
8. Mid-term transfer, unless warranted by compelling circumstances shall not be resorted to.

9. If husband/wife of the incumbents is also an employee of any of the two establishments, then they shall be accommodated in the same station, provided vacancies are available.
10. Transfer on request may be considered by the High Court, only if there exists any valid reasons for such request, but same is subjected to availability of vacancies in other district head-quarter or sub-division or on mutual transfer.
11. Ordinarily, an employee with disability should not be transferred from one station to other, unless public interest and administrative exigencies warrants.
12. Transfer of an incumbent may not be considered 6 (Six) months before his/her (immediate) retirement, as it may cause much difficulty in getting his pension after retirement.
13. On transfer, the incumbent will be entitled to T.A. and D.A. as per Government Rule. But if transfer is considered on the request of the incumbents, then he will not be entitled to any T.A. and D.A.
14. All individual cases of transfer are to be placed before the Chief Justice for order with recommendation of the concerned Portfolio Judge.
15. No request for transfer by a newly appointed employee shall be entertained until completion of 3(three) years of service.
16. Whenever a request for transfer from one district to another district is made by an employee and such request is acceded to, such an employee shall not carry his seniority to the establishment where he is transferred. In such a case of inter-district transfer on request, the transferred employee shall be placed at the bottom of the cadre in the establishment to which he is transferred, i.e., he will be treated as the junior-most in his cadre on the date of joining.
17. The Head of the Establishments are to forward representations for transfer of the staff under their establishment only in the month of November.
18. The Head of the Establishments while forwarding the representation for transfer are to mention about their objection/no objection, if any, in the event of transfer of the staff from their establishment.
19. While submitting transfer representation, the employee has to mention his/her date of joining in service along with a copy of his/her appointment letter and the category (General/OBC/SC etc.) to which he/she is appointed.

HC.XI-04/2021/128/RC: Pursuant to the directions passed by the Hon'ble Supreme Court of India vide its order dated 22nd April, 2021 in Civil Appeal No.1659-1660/2021 (Rahul S. Shah Vs. Jinendra Kr. Gandhi & Ors.), the Gauhati High Court has been pleased to make the following amendments to the Civil Rules and Orders of the Gauhati High Court in the following manner:

**Amendment
of Chapter
8 of Part I:**

"118 A. In suits relating to delivery of possession, the court must examine the parties to the suit under Order X in relation to third party interest and further exercise the power under Order XI Rule 14 asking parties to disclose and produce documents, upon oath, which are in possession of the parties including declaration pertaining to third party interest in such properties.

118 B. After examination of parties under Order X or production of documents under Order XI or receipt of commission report, the Court must add all necessary or proper parties to the suit in terms of Order I Rule 10 of the C.P.C., so as to avoid multiplicity of proceedings and also make such joinder of cause of action in the same suit.

118 C. In a suit for payment of money, before settlement of issues, the defendant may be required to disclose his assets on oath, to the extent that he is being made liable in a suit. The Court may further, at any stage, in appropriate cases during the pendency of suit, using powers under Section 151 CPC, demand security to ensure satisfaction of any decree."

**Amendment
of Chapter
9 of Part I:**

"134 A. The Court must, before passing the decree, pertaining to delivery of possession of a property ensure that the decree is unambiguous so as to not only contain clear description of the property but also having regard to the status of the property."

**Amendment
of Chapter
10 of Part I:**

The existing Rule 144 shall be re-numbered as Rule 144(1).

Thereafter:

"144 (2). In a money suit, the Court must invariably resort to Order XXI Rule 11, ensuring immediate execution of decree for payment of money on oral application.

144 (3). The Court exercising jurisdiction under Section 47 or under Order XXI of CPC, may not issue notice on an application of third-party claiming rights in a mechanical manner. Further, the Court should refrain from entertaining any such application(s) that has already been considered by the Court while adjudicating the suit or which raises any such issue which otherwise could have been raised and determined during adjudication of suit if due diligence was exercised by the applicant."

"203 (3). The Court should allow taking of evidence during the execution proceedings only in exceptional and rare cases where the question of fact could not be decided by resorting to any other expeditious method like appointment of Commissioner or calling for electronic materials including photographs or video with affidavits.

203 (4). The Court must in appropriate cases where it finds the objection or resistance or claim to be frivolous or mala fide, resort to Sub-rule (2) of Rule 98 of Order XXI as well as grant compensatory costs in accordance with Section 35A."

**Amendment
of Chapter
11 of Part I:**

"214 (5). In appropriate cases, where the possession is not in dispute and not a question of fact for adjudication before the Court, the Court may appoint Commissioner to assess the accurate description and status of the property. The cost of the Commission is to be borne by the parties."

**Amendment
of Chapter
13 of Part I:**

"246 A. In appropriate cases, the Court may, under Order XL Rule 1 of the C.P.C., appoint a Court Receiver to monitor the status of the property in question as custodial legis for proper adjudication of the matter, subject to the application submitted by any party."
