NOTIFICATION

The 12th September, 2019

No. FSC 18/2019/771.- Upon receipt of report from the Food Analyst to the Govt. of Assam and upon consideration of the same, it reveals that the sample of Packaged Drinking Water (Bisleri Brand) (With added Minerals) is unsafe in terms of the provisions of Section 3(1) (zz) of the Food Safety and Standards Act, 2006.

Whereas, the samples of Packaged Drinking Water (Bisleri Brand) (With added Minerals) bearing Batch No.:87(DD2IJD) and GDA B. No.89(RH/RA) do not conform to prescribed standard with respect to Fluoride content as laid down in Regulation 2.10.8 of Food Safety and Standards (Food Products Standards and Additives) Regulations, 2011 and declared un-safe according to Section 3(1) (zz) of Food Safety and Standards Act, 2006 by the Food Analyst to the Govt. of Assam vide Report No. FSS/G/22/19 dtd. 20/04/2019 and No. FSS/G/23/19 dtd. 20/04/2019 respectively thereof.

Therefore, in exercise of power conferred under Section 30(2) (a) of Food Safety and Standards Act, 2006, the undersigned hereby in the interest of public health prohibit the manufacture, storage, distribution and sale of Packaged Drinking Water (Bisleri Brand) (With added Minerals) manufactured by M/s. GD Aqua, Dolma Industrial Area, Vill.: Kamalpur Dinkar, P.O.: Baihata, P.S.: Kamalpur, Dist.: Kamrup, Assam-781380 in the State of Assam with immediate effect for a period of 30 (thirty) days.

Nothing in this order shall bar the manufacturer from producing Packaged Drinking Water (Bisleri Brand) (With added Minerals) for the purpose of testing and analysis towards improvement during the period of prohibition, in the presence of the Food Safety Officer.

The Designated Officers, Food Safety of the districts are hereby directed to strictly enforce this prohibition Notification and furnish the reports thereof accordingly without fail.

The Designated Officer, Food Safety, Kamrup District is also hereby directed to serve improvement notice under Section 32 of Food Safety and Standards Act, 2006 to secure compliance with the improvement notice within the specified period.
