No. CMP.E/379302/1.- Perused the review petition submitted by Sri Nikhil Biswas, Assam Yuvak Adarsha Cooperative Bahumukhi Society Ltd. under Section 111 of the Assam Cooperative Societies Act, 2007 for reviewing the order No. CMP.35/2020/224, dated 22nd June, 2023 as per order dated 30th June, 2023 passed by the Hon'ble Gauhati High Court in WP(C) No.3895/2023.

And also perused the reply of the review petition dated 20th July, 2023 submitted by Sri Nityananda Gogoi, Original Member of Assam Yuvak Adarsha Cooperative Bahumukhi Society Ltd.

The Hon'ble Gauhati High Court in its order dated 30th June, 2023, proposes that upon production of a certified copy of the order by the petitioner (1) i.e. Sri Nikhil Biswas the RCS, Assam will provide the complaint petition dated 30th September, 2022 submitted by respondent No. 5 i.e. Sri Nityananda Gogoi with all documents of the matter within the period of 7 days from the date of receipt certified copy of the order. After receipt of complaint and documents from the office of the RCS, Assam, the petitioner shall file their appeal/review against the order dated 22nd June, 2023 before the authority. The respondent No. 5 shall have to collect the copy of the appeal /review file by the petitioner through the office of the RCS, Assam and respondent No.5 also file his objection within the period of 14 days from the date of receipt of the appeal/review petition. The RCS, Assam shall hear the matter by giving an opportunity to the petitioner Society for personal hearing through it member or through learned counsel as well as the respondent No.5 within a period of 21 days thereafter. The Hon'ble GHC has disposed off the petition stating that the operation of the order bearing No. CMP.35/2020/244 dated 22nd June, 2023 shall remain suspended till the disposal of the instant appeal petition.

Sri Nikhil Biswas has submitted his appeal/review petition on 13th July, 2023 and respondent No. 5 Sri Nityananda Gogoi was provided with the appeal/review petition on 13th July, 2023. Sri Nityananda Gogoi submitted his objection on 20th July, 2023.

After receipt of objection reply from Sri Nityananda Gogoi, the RCS, Assam fixed the hearing on 7th August, 2023. On the date of hearing Sri Nikhil Biswas requested a copy of reply submitted by Sri Nityananda Gogoi. So, the matter was re-fixed on 28thAugust, 2023. In the meantime, Sri Nikhil Biswas has submitted a prayer petition on 23rd August, 2023 stating that his learned Advocate will be busy upto 1st September, 2023. So, the matter was re-fixed for hearing on 7th September, 2023.

On the date of hearing Smti. Kabita Das, i/c ARCS, Guwahati, Sri Nikhil Biswas, review petitioner, Sri Nityananda Gogoi, Sri Budheswar Dihingia, Sri Prafula Biswas, member of the Society, Sri Lohit Mohanta, Advocate on behalf of Sri Nityananda Gogoi, Chanitra Biswas, Sri Bhanu Biswas and Sri U.K. Gohain, Advocate on behalf of review petitioner were present.

The petitioner was heard and their allegation were perused. The main allegation of the petitioner is that Sri Nityananda Gogoi is not actually son of Monu Gogoi and his actual title is Baishya. Moreover he is not a member of Assam Yuvak Adarsha Cooperative Bahumukhi Society Ltd.

Secondly, there is a Cooperative Society at 'TilaBasti' area of village-Barila which is functioning

under the supervision of Sri Nityananda Gogoi and the name of the said society is "Amar Pathar Bahumukhi Krishipam Samabai Samity Ltd." having registration No. G-21/2012- 13 under the ARCS, Guwahati and one 'Sri Montu Baishya' who is the elder son of Nityananda is the president of the said Coop. Society and another son of Nityananda i.e. 'Sri Pinku Gogoi' is the Secretary of the said Coop. Society. In fact, Sri Nityananda Gogoi is not a member of review petitioner Society i.e. Assam Yuvak Adarsha Cooperative Bahumukhi Society Ltd. However, Sri Nityananda Gogoi always tries to suppress the actual fact in order to get the benefit in his favour.

In regards to the allegation of Sri Nityananda Gogoi not being son of Late Monu Gogoi, Sri Nityananda Gogoi submitted admit card of HSLC examination, Voters list of 1997 and EPIC card where in it is clearly stated that Sri Nityananda Gogoi is the son Late Monu Gogoi.

In regards to be existence of Cooperative Societies at 'Tila Basti' area of village -Barila and the name of the Amar Pathar Bahumukhi Krishipam Samabai Samity Ltd. having registration No.G-21/2012-13 under the ARCS, Guwahati. The existence of similar Society in the neighborhood is not barred as per Section-6 of Assam Cooperative Act, 2007 and Sri Nityananda Gogoi's son being members of the said Society does not amount to violation of the Act which would render Sri Nityananda Gogoi to be ineligible to be the member of Assam Yuvak Adarsha Cooperative Bahumukhi Society Ltd. The fact has been substantiate by the submission in earlier hearing wherein earlier proceedings of the Society reveal that Sri Nityananda Gogoi was a member of the Society in the year 1984 and 1986. The petitioner could not provide any substantiate proof of termination of membership of Sri Nityananda Gogoi during the later part of functioning of the Society.

As mentioned in the petition the decree of permanent in junction passed by Hon'ble court of Munsif, Guwahati stating Sri Nityananda Gogoi and his associates for interfering with the peaceful possession and employment of the member of the Society is a question of possession of the land and the undersigned is not empowered to pass the judgement on possession of land.

In view of the finding stated above, I Sri Narayan Konwar, IAS, Registrar of Cooperative Societies, Assam uphold the order No. CMP.35/2020/244 dated 22nd June, 2023.

Accordingly review appeal petition is disposed off.

Subject: Standard Operating Principles (SOP) for action to be taken for contaminated vegetables.

- 1) Inter-departmental Surveillance teams will conduct checks at entry points on vehicles carrying vegetable for sale in Guwahati. (Action: Surveillance teams)
- 2) All the routes carrying vegetables to Guwahati must be brought under surveillance, including riverine routes through the river Brahmaputra. (Action.Surveillance teams).
- 3) The vehicle carrying the vegetables must carry valid challan with the name of the consignee and details of consignment along with valid contact number. (Action: Surveillance teams)
- 4) The BARC BIOKIT will be used for testing samples for detection of 12 Nos. of pesticides of which 8 Nos. belonging to the organophosphate group (OP) and 4 Nos. belonging to carbamate group (OC) as per their protocol. (Action: Surveillance teams)
- 5) On testing positive which indicates the presence of pesticides, regulatory samples are to be collected immediately by the FSSAI as per their protocol. (Action: FS&DA)

6) The vehicle containing contaminated vegetables must not be allowed to proceed to the city to sell the vegetables as they could be containing harmful pesticides injurious to human health. (as per orders passed by the Hon'ble Guwahati high Court).

(Action: Home Dept.)

- 7) The vehicles carrying the contaminated vegetables will be made to be return back without entering the Guwahati city. (Action: Home& Transport Dept.)
- The Food Safety Officer (FSO) of the concerned District of the source of production of such vegetables shall keep the stock of such vegetables in safe custody of the Food Business Operator/ Farmer exercising his powers as laid down in Sec 38 (c) of Food Safety and Standard Act, 2006. In doing so, the FSG shall also carry out his responsibilities as laid down in Rule 2.3 of Food Safety and Standard Rules, 2011. (Action: FS&DA)
- 9) The surveillance teams must maintain a data base of samples being collected of the source of production along with the name of the farmer or aggregator.

(Action: FS&DN Agriculture)

10) For effective implementation, random checks is to be carried out in various wholesale and retail markets in Guwahati by the smaller teams formed with officials from FS &DA, Home, Agriculture and GMC authorities to conduct such checks.

(Action: All concerned Depts.)

- Back tracing of the contaminated vegetables should be carried out to trace the source of production and take necessary appropriate action against the traders of the contaminated vegetables.

 (Action: Agriculture/FS&DA)
- 12) Back tracing of source of pesticides which have residues of banned pesticides is to be followed up immediately. In case upon detection of the farmer using the banned pesticides, the source of procurement of inputs are to be gauged and proper investigation of source of supply is to be ascertained and necessary legal action be initiated against such dealers under Insecticide Act, 1968.

 (Action: Agriculture Dept.)
- In view of the extension of jurisdiction of Commissioner of Food Safety, Assam by the Hon'blc Gauhati High Court, testing of vegetable samples with BARC BIOKIT followed by collection of regulatory sample testing if required are to carried out by 17S &DA department from the markets/wholesale collection or wholesale aggregate points at the farmers field level. (Action: District Level Vegetable Surveillance Team)
- 14) Such regulatory tests are to be done frequently at vegetable growing belts preferably.

 (Action: District Level Vegetable Surveillance Team)
- 15) On detection of vegetables with contamination, such vegetables are to be isolated and transportation for sale in vegetable markets are to be prevented for consumption purposes.

 (Action: District Level Vegetable Surveillance)
- 16) Identification of the source of production is important to take necessary remedial measures. Thus proper documentation of the farmers and aggregators is necessary. Henceforth the following information is to be maintained in a registry by the aggregator/collector of vegetables:
- Name of market yard/Haat
- Weekly/Bi weekly market.

- Name of the transporter and Address.
- Name of the farmer who grows the crop with address and crop location
- Place of cultivation (riverine area /patta land etc)
- Name of crop along with area under cultivation.
- Marketable surplus (appox. quantity).

Details of Farmers and Aggregator with market

• Name and address of source(s) of procurement of inputs of pesticides by the farmer.

In no case, the aggregator will procure and market vegetables without the known source of production and identity of farmers.

In case, he collects surplus vegetables from other farmers, he must maintain the details of the farmer with the above mentioned information.

(Action: Agriculture Dept.)

A short format to be maintained at aggregator level is attached herewith which has to be carried by all transporter and producer at delivery point. Duplicate copy to be submitted for record.

(Annexure I)

17) Information is to be maintained in a registry by the Pesticide Retail outlets. The pesticide retailers must maintain a register in his retail outlet against the name of the pesticide and the crop for which it is purchased by the farmer. This will help in back tracing of the farmers in case crops are found with pesticide residue above MRL. (Action: Agriculture Dept.)
