No. DCTM 1/2012/62.- Whereas it is observed from the records that the Niz Borsola Gaon Panchayat Samabay Samity Ltd. registered under the Assam Coop: Societies Act. 2007 (Act IV of 2012) bearing registration No.T-10/2012 dt. 12th November, 2012.

Whereas the society has ceased functioning since long and the members have not taken step for its revival.

AND

Whereas inspection under Section 88 (1) of the Assam Coop; Societies Act. (2007) reveals that the society leaves no scope for its revival and suggests for liquidation.

Now, I Sri P. K. Das, Dist. Deputy Registrar of Coop; Societies, Sonitpur, Tezpur is of opinion that the registration of the society ought to be cancelled.

Therefore, in exercise of power conferred under Section 94 (2) of the Assam Coop: Societies Act. 2007 (Act. IV of 2012), I do hereby cancel the registration of the society.

Further, in exercise of power conferred under Section 95 Sub section (1) of the said Act., I do hereby appoint the liquidator of the Coop: Societies, Tezpur to be the Liquidator of the said society. IPRD.107/2017/246 dated 14th November, 2017 w.e.f. 7th November, 2017 as a result of his arrest and detention in custody beyond 48 hrs. by the CM Vigilance Cell in connection with Case No.08/2017 under Sec.120(B)/406/409/420 IPC RW Sec.13(2) Prevention of Corruption Act,1988 for alleged financial irregularities in the "Vision Assam Mission Assam" campaign in 2015-16.

Whereas, Disciplinary Proceeding under rule 9 of the Assam Services (Discipline and Appeal) Rules, 1964 was drawn up vide Show Cause Notice No.IPRD.107/2017/261 dated 17th November, 2018 bringing 6 (six) charges. Although the charged Officer submitted his reply dated 22nd January, 2019 denying the charges, but the Government being unsatisfied with his reply ordered continuation of Departmental Enquiry vide order No.IPRD.64/2018/28, dated 14th February, 2019.

Whereas, the Enquiry Officer, Shri Manoj Kumar, IAS, carried out the enquiry and concluded vide his report dated 2nd March, 2022 that out of the 6(six) consolidated charges brought in against the charged Officer, 3(three) charges have been established viz.

- Charge No.3 regarding gross misconduct and wilful violation of financial rules and CVC guidelines and manipulation by reducing the period of contract arbitrarily from four months to three months in some cases and two months or less in some other without carrying the cost analysis.
- Charge No. 4 regarding awarding of work to M/S Delta Publicity and M/S Pradip Advertising at much higher rates than what was quoted resulting in wasteful expenditure of public money amounting to Rs.78.461akhs.
- Charge No. 5 regarding compression of work arbitrarily in the work order without approval of higher authorities resulting in wasteful expenditure of public money.

Whereas, in compliance with Hon'ble Gauhati High Court's Order dtd.18th November, 2021, in W.P(C) No.338/2021, Shri Ranjit Gogoi was reinstated in service w.e.f.19th May, 2022 vide Order No.IPRD.08/2021/70, dtd.6th June, 2022 and attached with the Information, Public Relations, P&S Department, Dispur, without prejudice to the Departmental Proceeding against him.

Whereas, the Enquiry Report submitted by the Enquiry Officer was accepted by the Disciplinary Authority and a copy of the Inquiry Report was furnished to the charged Officer asking him to submit a reply in his defense. Shri Ranjit Gogoi submitted his reply vide letter dated 28th April, 2022, which was found to be non-satisfactory.

Whereas on careful consideration of the enquiry report, the materials on record and the submission made by Shri Ranjit Gogoi on the enquiry report, the Disciplinary Authority decided to impose the penalty of Compulsory Retirement as per Clause (v) under Rule 7 of the Assam Services (Disciplinary & Appeal) Rules, 1964 and F.R. 56 of the Fundamental Rules and Subsidiary Rules upon said Shri Ranjit Gogoi, DIPR, Assam with immediate effect and sought the views of the Assam Public Service Commission.

Whereas, the Assam Public Service Commission vide U/O issue No. 1648 dated 28th June, 2022 has agreed to the decision of the penalty; Now, therefore, the Governor of Assam is pleased to impose the

penalty of Compulsory Retirement as per Clause (v) under Rule 7 of the Assam Services (Disciplinary & Appeal) Rules, 1964 and FR. 56 of the Fundamental Rules and Subsidiary Rules upon said Shri Ranjit Gogoi, DIPR, Assam, from the date of issue of this order.

Further, the Governor of Assam is pleased to order that for the period of suspension w.e.f. 7th November, 2017 to 19th May, 2022, he shall not be entitled for anything else except the subsistence allowance already drawn for the period of his suspension. However, the period of his suspension shall be counted only towards pension purposes and other pensionary benefits.

Thus, the Departmental Proceeding drawn up against Shri Ranjit Gogoi, DIPR, Assam, is hereby disposed of.
