On receipt of the report/consent received from Inspector General of Police, CM's Special Vigilance Cell in regards to sharing of enquiry report, Departmental Proceeding was initiated against Shri Ranjit Gogoi and other accused. The Judicial Department has also advised to review the suspension of the charged officer and thereafter passed a Reasoned Order extending the suspension order by stating the grounds and the review exercise is to be carried out every three months and a decision either to lift or continue the suspension must be taken upon due application of mind on each occasion. Accordingly, the suspension of Sri Ranjit Gogoi was reviewed and decided to continue the suspension of Sri R. Gogoi vide Govt. Order No. IPRD.30/2011/261, Dated Dispur, the 31/01/2021; and

Whereas, after due consideration of all facts and circumstances relating to this matter it is seen that the Departmental Proceeding drawn up against Shri Ranjit Gogoi is yet to come to its logical conclusion. The entire Departmental Proceeding against the charged officer was based on official records pertaining to the office Shri Ranjit Gogoi held before the suspension and the period of his incumbency as Director of Information & Public Relations, Assam. All the relevant documents containing evidence against Shri Ranjit Gogoi is in public domain and is accessible by office of the Director of Information & Public Relations, Assam. Thus, it is considered expedient to ensure that confidentiality of the relevant documents and ensuring measures to avoid any tampering what so ever is prime importance for judicious objective and fact based conclusion of Departmental Proceeding instituted; and

Whereas, although, as per report of the Superintendent of Police, Chief Minister's Vigilance Cell, vide his letter No.SVC/R.S.I/Case No.08/2017/2020/1491, dtd.30.12.2020, the charge-sheet against the charged officer has been submitted before the Hon'ble Gauhati High Court, re-instatement of the charged officer may influence such material witnesses which will result in less than judicious and objective conclusion of the matter. Further, intimidation or coercion of witnesses against the charged officer also cannot be ruled out; and

The last review was done on 31/01/2021 and the period of 3 months expired on 30/04/2021. But due to the prevailing pandemic situation, the review was not undertaken during this time; and

Therefore, after careful examination of the case, the Governor of Assam is pleased to decide that Shri Ranjit Gogoi **may not be re-instated in service** till such time as the Departmental Proceeding drawn up against him is brought to logical conclusion.
