Rajashree Sharma joined as Wildlife Research & Education Officer on 22nd February, 1995 as per order FRE.102/94/19 dated 22nd February, 1995, the temporary post of WLR & EO was permanently retained by the Govt. of Assam w.e.f. 1st January, 2001 vide No. FRS.104/95/62 dated 14th February, 2001.

Whereas, Smti. Rajashree Sharma, Wildlife Research & Education Officer was allowed voluntary retirement vide Government Notification No.FRE.165/2002/277 dated 2nd November, 2012.

Whereas, Smti. Rajashree Sharma had applied for her pensioner benefits.

Whereas, Smti. Rajashree Sharma was absent from her duties for a total period of 7 years 3 months and 28 days.

Whereas, views of Finance (Esstt-A) Department was obtained and Finance (Esstt-A) Department vide U.O. No.368/16 dated 28th September, 2016 observed that-

".... as per FR-18, the incumbent should have been removed from the service after following due process. So, Department is requested to examine the case in the light of FR-18 and to ensure how VRS was granted in spite of the willful absence beyond 5 years and why Department has prepared to regularize the period of absence more that 5 years."

Whereas, Judicial Department was obtained and Judicial Department vide U.O. No.580/19 dated 18th November, 2019 observed that-

".... Since in the present case V.R. order was passed illegally, the same may be withdrawn. And a fresh D.P. may be initiated for the un-authorised absent, so as to invoke FR-18 as advised by Finance Department and conclude the same in accordance in law."

And, therefore, in view of the above, the Governor of Assam is pleased to withdraw the Voluntary Retirement order No.FRE.165/2002/277 dated 2nd November, 2012.
