Therefore, it is considered that continuation of Shri Ataur Rahman in the post of Chairman of the Guwahati Sub-Divisional Regulated Market Committee will dilute the credibility of the Market Committee.

That apart, in the Agenda No. 4 of the Minutes on the no confidence motion held on 25-01-2018, it appears that all the 8 members voted in favour of the no confidence motion against Shri Ataur Rahman.
