No.UDD(M)261/2017/112.- In exercise of power conferred under Section 13 of the Assam Municipal Act, 1956, the Governor of Assam in consideration of the resolution adopted in the Board Meeting of the Howly Municipal Board held on 13.09.2019, is pleased to divide the notified areas of Howly Municipal Board into 8 (eight) Wards in place of present 4 (four) with immediate effect. The number of Commissioners to be elected shall be 1 (one) from each of the 8 (eight) Wards. The areas included in each of the eight Wards are shown in the Schedule below.
