## NOTIFICATION

The 25th October, 2019

**No. HLA.681/2019/128.-** The Health & Family Welfare Department, Government of Assam hereby, makes the following amendments to the Guidelines for implementing Atal Amrit Abhiyan issued vide Notification No. HLA.995/2016/78 dated 06/02/2017 for implementation of **Vistarita Atal Amrit Abhiyan (Expanded AAA)**, namely:-

- 1 (i) These guidelines may be called the Guidelines for implementing Atal Amrit Abhiyan (First Amendment).
- (ii) They shall come into force from 1<sup>st</sup> November 2019.
- 2 (i) In the said guidelines, the existing sub-paragraph 4.3 shall be substituted by the following sub-paragraph, namely :-

"Upto Rs. 2.00 Lakhs annually will be reimbursed towards approved procedures and other services as part of the disease/ treatment packages on a complete cashless basis. Enrolled beneficiary will go to the empanelled hospital with the bar coded laminated card and come out without making any payment to the hospital, subject to a cap of Rs. 2.00 Lakh against all expenditures mentioned in these Guidelines. There will be an approved list of procedures in the 12 below specialities which only will be reimbursed.

  1. Cardiology and Cardiovascular Surgeries
  2. Neurological conditions
  3. Burns
  4. Cancer

5. Kidney diseases
6. Neo-natal diseases
7. ICU packages
8. Trauma
9. Critical care Paediatrics and Paediatric Surgery
10. Bone Marrow Transplantation
11. Japanese Encephalitis
12. Acute Encephalitis Syndrome"

(ii) The sub-sub-paragraphs (a), (b), (c) and (d) will remain unaltered.

- 3 (i) In the said guidelines, under the sub-paragraph 4.9.1, the following shall be inserted after existing text, namely :-

"For those procedures where rates are available under Central Government Health Scheme/ Pradhan Mantri Jan Arogya Yojana, the same rates will be followed and for those procedures where rates are not available, the rates will be finalised as per guidelines followed by National Health Authority, Government of India and Directorate of Health Research (DHR)."
