Anita Kumai was placed under suspension w.e.f 1st October, 2019, vide Notification No.PDS.236/90/191 dated 1st October, 2019, on grounds of gross indiscipline and misconduct leading to negligence of duty and subsequently, reinstated into service vide Order No. PDS.236/90/213 dated 18th September, 2020 and placed in E&M Division, T&D Deptt.;

Whereas, keeping in view the Circumstances, it was considered to get the charges enquired into by Inquiry Officer with Presenting Officer and accordingly, the Department appointed 10 and nominated PO vide order No.PDS.236/90/214 dated 18th September, 2020;

Whereas, during hearing taken by the O/o, Smti. Anita Kumai admitted the charges of remaining absent from duty, framed against her. However, she stated that due to her physical and mental condition she was unable to attend office and that it was not due to her willful negligence to duty;

Whereas, the Inquiry Officer, after conducting the Disciplinary Proceedings, submitted the Inquiry Report vide letter dated 7th October, 2020, wherein it was concluded that the charges of gross indiscipline and misconduct leading to negligence of duty and violation of Rule 3(1) (i), (ii) and (iii) of the Assam Civil Services (Conduct) Rules, 1965 are well established;

Whereas, the Inquiry Report was forwarded to Smti. Anita Kumai vide letter No.PDS.236/90/ 222 dated 2nd February, 2021 & PDS.236/90/223 dated 4th March, 2021 thereby giving her the opportunity of submission of representation, if any;

Whereas, the Delinquent Officer submitted a representation dated 23rd March, 2021 praying for release of her salary from October, 2020. On examination, it was found that the representation of Smti. Kumai did not contain any disagreement with the findings of the Inquiry Officer in the Inquiry Report and any new facts which warranted review of the Inquiry Report or the Disciplinary Proceeding;

Whereas, the matter was also referred to the Legal Remembrancer, Judicial Department, Government of Assam, upon which it was opined that, the Deptt. on conclusion of the Departmental Proceeding, may impose penalty of Compulsory Retirement as punishment in terms of Rule 7 of the Assam Services (Discipline & Appeal) Rules, 1964 and that if there is continuous absence from duty for 5 years it attracts provision of F.R. 18. Judicial Deptt., Assam advised the disciplinary authority to consider the matter in its entire and impose appropriate punishment as it deems fit.

Whereas, the Disciplinary Authority asked the Delinquent Officer vide letter No.E- 8290/1/ 184485/2023 dated 30th May, 2023 to appear before the District Medical Board and furnish report in respect of her health condition. Accordingly, the Delinquent Officer appeared before the District Medical Board, Kamrup (M) on 4th July, 2023.

Whereas, in the medical report of the District Medical Board, Kamrup (M) forwarded by the Joint Director of Health Services, Kamrup (M) on 12th July, 2023, it was certified that on clinical examination and verification of the medical documents of Smti. Kumai the Board is of the opinion that she has been suffering from fracture neck of the left femur with inability to stand and walk properly without support. She is under continuous supervision and care of orthopedic specialist and physiotherapist.

Whereas, after perusal of the Inquiry Report, report of the District Medical Board and the materials on record, the Government of Assam in the Transformation & Development Department, in view of the facts and circumstances decided to inflict the penalty of compulsory retirement upon the delinquent officer under Rule 7(v) of the Assam Services (Discipline and Appeal) Rules, 1964;

Whereas, on consultation under Rule 10 of the Assam Services (Discipline and Apeal) Rules, 1964, the Assam Public Service Commission (APSC) has agreed to the Government Decision of imposing penalty of compulsory retirement with regard to the Disciplinary Proceedings drawn up against the delinquent officer vide U/O Issue No.1733 dated 7th September, 2023;

Whereas, the Government of Assam in Transformation & Development Department is satisfied that the penalty under Rule 7(v) of the Assam Services (Discipline and Appeal) Rules, 1964, shall be at the ends of justice, keeping in view of the fact that the incumbent is not physically in sound condition and will be able to get her pension while staying at home;

Now, therefore, the Governor of Assam is pleased to impose the penalty of Compulsory Retirement upon Smti. Anita Kumai, Asstt. Research Officer, T&D Deptt. under Rule 7 (v) of the Assam Service (Discipline & Appeal) Rules, 1964, with immediate effect, in public interest to do so with the following conditions, as per OM No.FEG.249480/17 dated 13th January, 2023 of Finance (Estt.-A) Deptt., Assam.

- 1. The salary for the period under suspension of Smti. Anita Kumai shall be limited to the subsistence allowance only, as entitled.
- 2. The period of unauthorized absence of Smti. Anita Kumai shall be treated as on Extra Ordinary Leave without pay and allowances, only for pension purpose as per Rule 14(5) of Leave Rules, 1934 and FR 85(c).
- 3. Earned Leave may be granted to Smti. Anita Kumai for the period w.e.f. 11th April, 2012 to 15th August, 2012 and w.e.f. 27th August, 2012 to 10th September, 2012, subject to availability of Leave at her credit and on receipt of Leave Admissibility Report from the Accountant General, Assam, following due procedure.
- 4. Salary may be released to her for the period she was on duty. The Disciplinary Proceeding drawn up against Smti. Anita Kumai is thus disposed of.
