No. RBEB. 33/2019/12.-It has been observed that many officers of the Public Works Department, particularly Junior Engineers, have been seeking promotion to the next higher post of Assistant Engineer under the provision of Rule 11(4)(c) of the Assam Engineering (PWD) Service Rules, 1978 after acquiring higher education qualification (B.E./ B.Tech Degrees) through distance mode of education.

In view of the above, the Department finds it necessary to clarify the matter after the Hon'ble Supreme Court of India's Judgment Dated 3.11.2017 passed in Civil Appeal Nos. 17869-17870/2017 (Arising out of Special Leave Petition (C) Nos. 19807-19808/2012) regarding Engineering Degrees obtained through Distance mode of education. Hence, keeping in tune with the Hon'ble Supreme Court of India's Judgment, any and all Engineering Degrees obtained through Distance Mode of Education is sought to be discouraged and discounted in matters of promotion and recruitment under the Department.

The matter of promotion of Junior Engineers under Rule 11(4)(c) of the Service Rules have long been examined by the Department and it is found necessary to streamline the promotion procedure by reading together provisions of the Study Leave Rules 1963, as many officers apply for promotion by merely producing Higher Educational certificate without valid permission from the Govt. The operation of the said Rule too frequently also violates the right of the senior-most Junior Engineers for promotion to the higher post of Assistant Engineer as many junior officers avail promotion by obtaining Degrees through Distance Mode of Education, which is rampant and leads to frequent litigation.

Therefore, pursuant to the powers conferred by Rule 8 of the Assam Engineering (PWD) Service Rules, 1978, the Public Works Department hereby modifies the Schedule II appended to Rule 8, to exclude Degrees in any branch of Engineering, obtained through distance mode of education, by whatever name called, from the list of academic qualification of a candidate for direct recruitment mentioned under Schedule II of the Service Rule.

It is also clarified through this O.M. that only officers who avail study leave with approval of the Administrative Department and concurrence of Finance Department, will come under consideration for promotion under Rule 11(4)(c) of the Assam Engineering (PWD) Service Rules, 1978 subject to the Minutes of the discussion held on 23.12.2002 in connection with fixation of ceiling for granting Study Leave.
