OFFICE MEMORANDUM

- 1. The Governor of Assam is pleased to sanction Ex-gratia grant of Rs. 50.00 lakh to the next of kin/ legal heir of:
 - i. Doctors, Paramedical staff, other employees of health department on duty.
 - ii. Employees on duty of private hospitals who have signed MOU with Health Department under PMJAY and AAA during corona outbreak.
 - iii. Policemen and other government officers and staff on duty.
 - iv. Employees of societies/ authorities/ PSUs serving under Govt. of Assam
 - v. Journalists on duty.
 - vi. Home guards on duty
 - vii. Casual Employees of the Government of Assam and various societies on duty.

who died due to COVID-19 disease contracted while performing official duties in combating the COVID-19 pandemic as per decision taken in Council of Ministers' meetings held on 07-04-2020 and 27-08-2020.

- 2. The Deputy Commissioner of the concerned district will submit the proposal in respect of the beneficiary to the Revenue & D.M. Department along with his specific views and recommendations, supported with the following information/documents:
 - a. Name & Address along with a photograph of the (i) Deceased person, (ii) NOK/legal heirs with valid address proof documents.

- b. Bank details of the beneficiary with IFSC Code No.
- c. Next of Kin Certificate/ Legal Heir Certificate issued by the competent authority.
- d. Death Certificate issued by competent authority on the basis of certificate issued by the State Death Audit Board constituted by Health & Family Welfare Department, Govt. of Assam due to outbreak of COVID-19.
- e. Recommendation of Joint Director, Health & Family Welfare of the Concerned District.
- f. The certificate from concerned Department regarding the engagement of the deceased person on COVID-19 control duty.
- g. The Deputy Commissioner, will certify that the employee is on duty in the State's battle against the COVID-19 while the Corona Virus has been contracted by such employees. The Deputy Commissioner, while issuing such Certificate can call upon a report from the Head of Office to ascertain nature of duties entrusted upon such an employee.
- h. Recognition / Accreditation card issued by the District Information & Public Relations officer in case of journalists.
- 3. The amount of Rs. 50 lakh (Rupees fifty lakh) shall be sanctioned in 1(one) instalment.
- 4. After disbursement of each instalment of Ex-gratia grant concerned Deputy Commissioner will submit particulars of drawal of the amount (viz. T.V. No. and Date).
- 5. The Ex-Gratia Grant is admissible only for the pandemic of COVID-19 and it will remain in force with effect from 23rd March, 2020 up to the time the disease persists subject to review thereafter by the State Govt.
- 6. The detailed terms and conditions governing the above mentioned Ex-gratia grant have been laid down in the Guidelines issued vide Government Notification No. RGR(RRR)498/2020/24 dated 02/09/2020 and Office Memorandum No.RGR(RRR)498/2020/27 dated 08-10-2020.
