### **NOTIFICATION**

The 15th November, 2019

**No.HLA.1171/2010/326.-** In exercise of the powers conferred by the proviso under Article 309 of the Constitution of India, the Governor of Assam is hereby pleased to make the following Rules further to amend the Assam Drugs Control Organisation Service Rules, 1994, hereinafter referred to as the principal Rules in the manner hereinafter appearing, namely:-

Short title and1.(i)These rules may be called the Assam Drugs ControlcommencementOrganisation Service (Amendment) Rules, 2019.

- (ii) They shall come into force on the date of their publication in the Official Gazette.
- Amendment of2.In the principal Rules, in rule 6, in sub-rule 1, in clause (d), forrule 6the last line, appearing after the word and punctuation mark<br/>"recruitment.", the following shall be substituted, namely :-

"(d) The select list prepared by the Recruitment Board for the fresh appointments to vacant sanctioned posts shall contain names equal to the number of vacant posts notified at the time of calling for applications for filling up of the posts." Amendment of3.In the principal Rules, for the existing rule 7, the followingrule 7shall be substituted, namely :-

"(7) A candidate for direct recruitment to the service shall be within the age limits as laid down by the Government from time to time with relaxation in case of candidates belonging to special categories like Scheduled Castes and Scheduled Tribes and any other categories in accordance with the orders of the Government for the time being in force."

Amendment of 6. In the principal Rules, in rule 11,-

- (i) in clause (i), for the existing words, figures and punctuation mark "2(two) years", occurring between the words "of" and "on", the words, figures and punctuation mark "1(one) year" shall be substituted.
- (ii) in clause (ii), for the existing words, figures and punctuation mark "3(three) years", occurring between the words "of" and "on", the words, figures and punctuation mark "2(two) years" shall be substituted.
- Amendment of 7. In the principal Rules, in rule 12,-
- rule 12

(i) for the existing sub-rule (4), the following shall be substituted, namely:-

"(4) The selection shall be made on the basis of seniority with due regard to merit."

(ii) in sub-rule 6, in clause (a), for the words and punctuation mark "unless it considers any change necessary. If the Appointing Authority considers it necessary to make any change in the list received from the Board, shall inform the Board of the changes proposed and after taking into account the comments, if any, of the Board, may approve the list finally with such modifications, if any, as may in its opinion, be just and proper", occurring after the word "list" shall be substituted by the words "with any modifications, as may in its opinion, be just and proper, with intimation to the Board."

- (iii) sub-rule (6)(b)(i), sub-rule(6)(b)(ii), sub-rule (8), sub-rule (9)
   and sub-rule (10) shall be deleted and sub-rule 6(a) shall be
   renumbered as sub-rule (6).
- Amendment of8.In the principal Rules, for the existing rule 13, the followingrule 13shall be substituted, namely:-

"(13) The Board for considering promotion to the posts of Drugs Controller, Joint Drugs Controller, Deputy Drugs Controller and Senior Inspector of Drugs shall consist of the following:-

(i)Principal Secretary/Commissioner and Secretary/ Secretary to the Government of Assam, Health and Family Welfare---Chairman

(ii) Secretary to the Government of Assam, Personnel Department or his nominee not below the rank of Deputy Secretary to the Government of Assam----- Member

(iii) Secretary to the Government of Assam, WPT and BC Department or his nominee not below the rank of Deputy Secretary to the Government of Assam

(iv) Commissioner, Food Safety and Drug Administration, Assam, -----Member

(v)Joint Secretary/ Deputy Secretary to the Government of Assam, Health and Family Welfare--- Member Secretary."

Amendment of9.In the principal Rules, in rule 14, in sub-rule (1), after the<br/>clause (b), the punctuation mark "." shall be substituted with<br/>the punctuation mark ";" and the following two new clauses (c)<br/>and (d) shall be inserted, namely:-

"(c) if he/she has more than two children;

(d) if he/she violates the legal age of marriage."

Amendment of10.In the principal Rules, in rule 25, after sub-rule (2), a new sub-rule 25rule (3) shall be inserted , as in the following, namely:-

"(3) A member of the service shall strictly follow norms of two children family in accordance with the provisions as laid down by the Government from time to time."

Amendment of11.In the principal Rules, for the existing Schedule-I, the followingSchedule-Ishall be substituted, namely:—
