GOVERNMENT OF ASSAM ORDERS BY THE GOVERNOR DEPARTMENT OF PERSONNEL ::: PERSONNEL (B)

NOTIFICATION

The 27th October, 2020

No. ABP.98/2017/36.- In exercise of the powers conferred by Article 318 of the Constitution of India the Governor of Assam is hereby pleased to make the following regulations further to amend the Assam Public Service Commission Regulations, 1951, hereinafter referred to as the principal Regulations, namely:-

Short title and commencement

- (1) These regulations may be called the Assam Public Service Commission (Amendment) Regulations, 2020.
 - (2) They shall come into force on the date of their publication in the Official Gazette.

Substitution of Regulation 4

Top.

- In the principal Regulations, for the existing regulation 4, the following shall be substituted, namely:-
 - " 4 (i) The Commission shall consist of One Chairman and six other Members including at least one Woman Member.
 - (ii) The Chairman and the Members shall be competent, honest and impartial person of outstanding ability, integrity and high reputation who command the confidence of the people and who would not allow themselves to be deflected by an extraneous consideration from discharging their duties.

- (iii) At least three out of the Chairman and Members of the Commission shall be persons who at the date of their respective appointments have held office for at least ten years either under the Government of India or under the State Government and or have served, atleast, as Secretary under the State Government or in equivalent post.
- (iv) The other Members should be eminent persons who is a Principal or Professor of University/Government College including professional Colleges or aided colleges or a reputed Advocate, Chartered Accountant. Medical Practitioner or other professional.
- (v) The Governor of Assam or his nominee shall administer the oath of office to the Chairman and Members before entering upon their office according to the following form, namely:
- 'I, A.B. having been appointed as Chairman/ Member of the Assam Public Service Commission do swear in the name of God that I will bear true faith and allegiance to the Constitution of India, as by law established, that I will uphold the sovereignty and integrity of India, that I will duly and faithfully and to the best of my ability, knowledge and judgment perform the duties of my office without fear or favour, affection or ill-will and that I will uphold the Constitution and the laws.'".
