No.IPRD.88/2002/383.- Whereas, the Hon'ble Chief Minister, Assam visited Silchar on 4th June, 2020 to take stock of the situation arising out of landslides and held a very important meeting in the office of the Deputy Commissioner, Cachar. But, as per the report of the Director of Information and Public Relations, Assam, it is found that Smti. Indrani Goswami, Deputy Director of Information and Public Relations, Barak Valley Region (now under suspension) remained absent from duty without obtaining prior permission from the competent authority and therefore serious mismanagement took place regarding media persons who came to cover the programme of the Hon'ble Chief Minister, Assam. A number of media persons got agitated and left the venue causing much embarrassment to the Govt.; and

Whereas, after careful examination of the report submitted by the Director of Information and Public Relations, Assam, the Government has considered this as a serious misconduct and gross negligence of duty on the part of Smti Indrani Goswami for causing an embarrassing position to the Govt and therefore, pending drawal of Departmental Proceeding, Smti Indrani Goswami was placed under suspension under Rule 6(1)(a) of the Assam Services (Disciplinary & Appeal) Rules, 1964 with immediate effect and further orders, vide notification No.IPRD.88/2002/340 dated 15/06/2020 and show cause notice was already issued to her vide letter No.IPRD.23/2020/53 dated 26/08/2020.

Whereas, as per the O.M No.ABP.13/2018/Pt/35 dated 04/02/2020 of the Personnel (A) Department, the review exercise is to be carried out every three months and a decision either to lift or continue the suspension must be taken upon due application of mind on each occasion and also to review the suspension of the charged officer and thereafter passed a Reasoned Order extending the suspension order by stating the grounds.

Whereas, after careful examination of all facts and circumstances relating to this matter it is seen that the Departmental Proceeding drawn up against Smti Indrani Goswami is yet to come to its logical conclusion. The entire Departmental Proceeding against the charged officer is based on official records. Further, intimidation or coercion of witnesses against the charged officer also cannot be ruled out.

Therefore, after careful examination of the case it has been decided that Smti Indrani Goswami may not be re-instated in service till such time as the Departmental Proceeding drawn up against her is brought to its logical conclusion.

The officer informed that he was posted at Palashbari Range under Kamrup East Division vide transfer order dated 01.07.2017. As informed, her wife has been suffering from uterus Leukemia disease as well as Gold bladder disease and undergoing medical treatment at Guwahati who needs constant care and treatment. The officer requested to post in and around Guwahati considering ailment of his wife.

Now after careful examination of the matter, it has been observed that Sri Manoj Kumar Das, Forest Ranger has some issues related to his wife's ailment. But it has also been observed that the officer has completed more than 3 years of continuous service in Guwahati. The Department is on the view that in the interest of public service, Sri Manoj Kumar Das, Forest Ranger and 8 others were transferred and posted vide notification dated 01.09.2020.

In view of the above circumstances and after careful consideration of the facts and other relevant materials, grievances and problems faced by the officer and keeping view of greater public interest, as there is requirement of officers (4 nos. of Ranges are vacant) and extant transfer policy it has been decided by the Competent Authority to keep in force the transfer and posting order dated 01.09.2020 in respect of Sri Manoj Kumar Das, Forest Ranger and therefore the officer has to proceed for joining the new place of posting i.e., as Forest Ranger, i/c Helem (SF) Range under Sonitpur (SF) Division.

The officer also stated that the officer was posted during 2012-14 as Range Officer, BIEO in Guwahati under Home Department on deputation, as Range Forest Officer in Sonapur Range under Kamrup East Division during 2015-17, and Range Forest Officer at Protection Squad Range under Kamrup East Division since April, 2017 to till date. It appears that the Officer has been posted in an around Kamrup District for last 7 (seven) years. It has been observed that Shri Dalim Das, FR has been working in an around Guwahati for several years and also has medical issues.

After careful consideration of the above facts and other relevant materials and also keeping view of public interest, it is observed that there is requirement of officers at Gogamukh SF Range under Lakhimpur SF Division, therefore competent authority may direct Shri Dalim Das, FR to join at Gogamukh SF Range,

or

may consider to post him in any vacant post 150/200 KM away from Guwahati.
