No. E 236248/108.- Whereas, Sri Munindra Bhuyan, Senior Food Safety Officer, S/o Late Tarini Bhuyan, House No.24, Prachin Kalor Ganesh Mandir Path, Rajgarh by lane no. 07, Guwahati - 781003, has been accused by CM's Special Vigilance Cell, for allegedly visiting of foreign countries several times without Government approval, in connection with Chief Minister's Special Vigilance Cell P.E. No.04/ 2021;

Whereas, as sought by Superintendent of Police, Chief Minister's Special Vigilance Cell, Assam vide letter No. SVC/RI/CASE No,0l/2023/2136 dated 1st September, 2023 to sanction order, in connection with Vigilance PS Case No. 01/2023 U/S 13(1) (b)/ 13 (2) of the PC Act 1988 (as amended 2018), to prosecute Sri Munindra Bhuyan, who had also been accused for amassing assets which is disproportionate to his known sources of income, committing the offence of criminal misconduct and abusing his official position as a public servant for pecuniary advantages;

Whereas, this Department vide order No. eCF No. 379986/53 dated 11th October, 2023, had accorded sanction under section 19 of the PC Act, 1988 (as amended 2018), to prosecute the accused public servant, Sri Munindra Bhuyan, the then Senior Food Safety Officer, Kamrup (Metro) for commission of offences U/S 13(1) (b)/13(2) of the Prevention of Corruption Act, 1988 (as amended in 2018), and for any other offences arising out of the said facts and for taking cognizance of the said offence/ offences by the Court having competent jurisdiction;

Whereas, Sri Munindra Bhuyan was issued show cause notice vide letter No. HLA.143/2017/55 dated 18th April, 2022, charging him with insubordination, gross misconduct, and violation of the Assam Civil Service (Conduct) Rules;

Whereas, Sri Munindra Bhuyan, vide letter dated 5th May, 2022, submitted a written statement in his defence explaining the circumstances of the case, wherein the officer denied all the charges framed against him;

Whereas, after careful examination of the written statement in defence submitted by Sri Munindra Bhuyan and the materials on record, it was considered to get the charges enquired into by an Inquiry Officer alongwith a Presenting Officer.

Whereas, the Inquiry Officer, after conducting the Disciplinary Proceedings, submitted the Inquiry Report vide letter dated 23rd September, 2022, wherein it was concluded that the charges of gross misconduct and violation of Rule 3(1)(1), 3(1)(ii) and 3(1)(ii) of the Assam Civil Services (Conduct) Rules, 1965 are well established;

Whereas, after perusal of the Inquiry Report and the materials on record, the Government of Assam in Health & Family Welfare Department, decided to inflict the penalty of withholding of one increment upon the delinquent officer under Rule 7(ii) of the Assam Services (Discipline and Appeal) Rules, 1964;

Now, therefore, the Government of Assam in Health & Family Welfare hereby imposes the penalty of withholding of one increment with cumulative effect upon Sri Munindra Bhuyan, under Rule 7 (ii) of the Assam Service (Discipline & Appeal) Rules, 1964.

The Disciplinary Proceeding drawn up against Sri Munindra Bhuyan is thus disposed of.

5. As for publication of any matters in a Gazette, Extraordinary, the existing procedure whereby the prior approval of the General Administration Department is to be obtained will continue.
