**No. FSA.71/2021/45.-** The Governor of Assam is pleased to make the following guidelines, namely, Assam State Consumer Welfare (Corpus) Fund guidelines, 2021 for procedure of making grant, utilization, management, etc. of the Fund of Consumer Welfare (Corpus) Fund:

#### Background/Introduction

The Government of India, Ministry of Consumer Affairs, Food and Public Distribution Department of Consumer Affairs Krishi Bhawan, New Delhi issued directives to the States and union Territories to set up their own Consumer Welfare Fund at the State level to assist Voluntary Consumer Organizations for undertaking publicity measures and other activities relating to consumer protection vide letter D.O. No.0-12011/05/2016-CWF dated 01.03.2018.

Accordingly. a Welfare Fund is created for VCOS/Institutions/Organizations promotion of consumer awareness and protection of Consumer Right.

The fund will be operated by the Food, Civil Supplies and Consumer Affairs Department Government of Assam and shall be known as State Consumer Welfare(Corpus) Fund.

#### **Objective**

Any applicant overall objective of the State Consumer Welfare (corpus) Fund is to provide financial assistance to promote and protect the interest and welfare of the consumers and strengthen the consumer movement in the State more particularly in the rural areas.

#### Procedure for applying for financial assistance

The application, who is desirous of seeking financial assistance from the State Consumer Welfare(Corpus) Fund, the application should be addressed to:

The Secretary, Government of Assam, Food, Civil Supplies and Consumer Affairs Department, Dispur, Guwahati-6

The application should be accompanied with annual reports, audited statement of accounts for the last three years separately for each year, annual activity reports for three years separately for each year. Memorandum of association, regulations, list of members and such other information's are necessary for the grant. In case of reputed organizations/institutions the Department may relax the eligibility criteria. The audited statement of accounts of the organizations must bear the registration number and official stamp of the Chartered Accountant. Copies of all other documents required for the applications must be attested by the gazetted officer.

#### **Eligibility conditions**

Any agency/organisation/institution engaged in consumer welfare activities for a period of three years and registered under the Companies Act. 1956 (1 of 1956) or under any law considerable for the time being in force may apply. However, NGOS of repute in the State with experience in other social welfare schemes are also eligible to apply.

(N.B: Preference will be given to the organizations having experience of state-wide nature in case, a group of organizations approach the Department with a common project, one organization may function as a mother unit and it should not be necessary for all participants to fulfil the condition of three years.

Panchayat Samity/Gram Panchayat level cooperatives of consumers specially of women, scheduled castes and scheduled tribes will be given preference Scheme on spreading consumer awareness through literature and audio-visual programmes sponsored by the State Government may also be brought under purview of State Consumer Welfare Fund subject to financial limit of the grant.

#### Extent of Assistance

The total quantum of assistance for an individual application shall not exceed Rs.5.00 lakhs Assistance will be limited to 90% of the approved cost. In exceptional cases, however, 100% assistance may be considered. The quantum of assistance will be decided by the Standing Committee considered by the State Government.

#### Purpose

The financial assistance will be extended, mainly for the following purposes:-

- 1. Production and distribution of literature and audio-visual materials for spreading consumer literacy and awareness building programmes for consumer education.
- 2. Setting up of facilities for the training and research in consumer education and related matters on regional basis.
  - 3. Community based rural awareness projects.
  - 4. Setting up of complain handling/counselling/guidance mechanism like Consumer Guidance Bureau.
  - 5. Setting up of Consumer Product Testing Laboratories.
  - 6. Building up infrastructural facilities for organising consumer education activities on a permanent basis at the sub-division, district and block levels.
  - 7. The projects not covered by the above, but in the opinion of the Department for the purposes can tackle pressing social problems and maximize consumer welfare.

#### Comment

The following items may qualify for assistance:-

- 1. Only for non-recurring expenditure;
- 2. Purchase of equipments,
- 3. Purchase of office furniture:
- 4. Changes for delivery of services;
- 5. Other charges as may be considered necessary by the Department for the purpose to ensure proper implementation of the programmes/projects. Construction of buildings and purchase of high value items of furniture and equipment and salary of staff on recurring basis beyond the prescribed limit will not be covered under the scheme. However, it may be relaxed only in case of laboratories set up under the scheme for purchase of testing equipments at the discretion of the Department.

(N B:-Payment of salaries or wages of staff on recurring basis will not be considered as a general rule but appointment of some expenditure/professional staff integral part of the project may be considered in deserving cases for a limited period. Such expenditure should not, however, exceed 15% of the total project cost and may be considered depending on nature of the project.

#### **Terms and Conditions**

- 1. The fund should not be used for any party or political propaganda.
- 2. Quarterly progress reports of the progress/implementation of the programme/project should be submitted through the respective Deputy Commissioners to the Consumer Affairs Department, Government of Assam. regularly. In case of non-submission of reports within scheduled date no further grant will be released and the amount already paid and received by the applicant shall be recovered with 15% compound interest thereon. The organizations/institutions receiving grant shall submit Utilization Certificate in prescribed format.

#### Constitution of the Committee

The Committee constituted by the State Government in Consumer Affairs Department shall make recommendations for utilization of the money credited to the consumer welfare (Corpus) Fund for the welfare of the consumer and to spread consumer education.

- 1. The committee shall consist of the following members namely:
- (a) The Secretary of the Consumer Affairs Department, who shall be the Chairman of the Committee.
- (b) Representative of the finance Department.
- (c) Director, Consumer Affairs & Fair Business Practices.
- (d) Joint Secretary in-charge of the Consumer Affairs Department, who shall be the Member Secretary.

(Provided that the chairman of the committee, may invite representatives of such Organization/council to the meetings as he deems fit and as and when necessary.

2. The Committee shall be a standing Committee.

#### **Procedure for Conduct of Business**

The Committee shall meet as and when necessary, but not more than three months shall intervene between any two meetings. The Committee shall meet as such time and place as Chairman of the Committee may deem fit.

- 1. The meeting of the Committee shall be presided over by the chairman, and in the absence of the Chairman, the Member Secretary shall preside over the meetings of the Committee.
- 2. Each meeting of the committee shall be called by giving notice in writing to every member of not less than ten days from the date of issue of such notice.
- 3. Every notice of the meeting of the committee shall specify the place and the day and hour of the meeting and shall contain statement of business to be transacted there at.
- 4. No proceeding of the Committee shall be valid unless it is presided over by the Chairman or Member Secretary and a minimum 2 other members are present.

#### Powers and Functions of the Committee

- 1 The committee shall have the power:-
- (a) To require any applicant to produce before it or a duly authorized officer of the State Government, such books, accounts, documents, instruments or commodities in custody and control of the applicant, as may be necessary for proper evaluation of the application.
- (b) To require any applicant to allow entry and inspection of any premises from which activities claimed to be for the welfare of Consumers, are stated to be carried on to a duly authorized officer of the State Government.

- (c) To get the account of the applicants audited for ensuring proper utilization of the grant.
- (d) To require any applicant in case of any default or suppression of material information on his part to refund in lump-sum the sanctioned grant to the Committee and to be subject to prosecution under the Act.
- (e) To recover any sum due from any applicant in accordance with the provision of the Act.
- (f) To require any applicant/applicants to submit a quarterly report indicating proper utilization of the grant.
- (g) To reject an application placed before it on the basis of involvement of factual inconsistency or inaccuracy in the material particulars.
- (h) To recommend minimum financial assistance by way of grant to an applicant having regard to his financial status and importance and utility of nature of activity under pursuit after ensuring that the financial assistance provided shall not be misutilised.
- (i) To require State Consumer Protection Council to formulate broad guidelines for considering the projects/ proposals for the purpose of incurring expenditure from the Consumer Welfare Fund.
- (j) To identify beneficial and safe sectors, where investments out of Consumer Welfare Fund may be made and make recommendations, accordingly.
- 2. The Committee shall not consider an application, unless it has been inquired into in material details and recommended for consideration accordingly by the Member Secretary.

#### Available Consumer Welfare Fund

The Committee shall make recommendations -

- (a) for making available grants to an eligible applicant.
- (b) for investment of the money available in the State Consumer Welfare(Corpus) Fund.
- (c) for making available grants, (on a selective basis) for reimbursing legal expenses incurred by a complainant or class of complainants in a consumer dispute after its financial adjudication.
- (d) For making available grants for any other purpose recommended by the State Consumer Protection Council.
