No. SEC.04/2018/162.- In exercise of powers under Rule 4 of the Guwahati Municipal Corporation Election Rules, 1973 and on the recommendation of the Deputy Commissioner, Kamrup(M), the following Officers are notified as Registration Officers for preparation, publication, revision and correction of Electoral Roll in respect of the Guwahati Municipality Wards indicated against their name for conduct of the forthcoming election to the Guwahati Municipal Corporation. Incase of unavailability of any of the notified Officers, the Deputy Commissioner, Kamrup(M) is hereby authorised under the provision of Rule 19-A of the aforementioned Rules to appoint another suitable officer as Registration Officer for the concerned Ward, with intimation to the Commission.

The process from preparation to final publication of the Electoral Roll shall be in accordance with Rules 5, 6, 7, 8, 9 and 10 of the Guwahati Municipal Corporation Election Rules, 1973 (as amended upto date). The Deputy Commissioner, Kamrup(M) will designate a location within the Ward itself for receiving claims and objections and for its disposal by the Registration Officer. The Deputy Commissioner, Kamrup(M) shall be responsible for supervising the entire process who will also send feedback to the Commission from time to time till final publication of the Electoral Roll as per the aforementioned Rules.
